1. We have reviewed the accompanying statement of unaudited financial results of **Padmanabh Industries Limited** for the quarter ended 30th June, 2026 which are included in the accompanying "Statement of Unaudited Financial Result for Quarter ended June 30, 2026" together with relevant notes thereon.
