The Senate has confirmed Jay Clayton as the Director of National Intelligence, putting a permanent head in place weeks after

Dr Anthony Fauci on Wednesday invoked the Fifth Amendment and declined to answer questions during a Republican-led Senate hearing on his handling of the Covid pandemic. Fauci was subpoenaed by Republican Senator Rand Paul of Kentucky, who has accused him of misleading lawmakers over the pandemic's origins. Fauci denied the allegations, saying he followed his attorney's advice by refusing to testify.

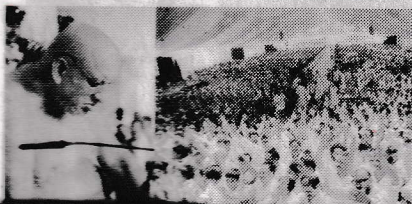
