This is to inform you that ICICI Prudential Mutual Fund (the Fund) including iSIF under its various schemes/investment strategies holds equity shares of Shadowfax Technologies Ltd. (the Company), listed on your stock exchange.

The Fund under its schemes/investment strategies has carried out net acquisition of 89,44,443 shares of the Company on July 24, 2026. As a result, the shareholding of the Fund has increased by more than 2% of the paid-up capital of the Company as compared to previous disclosure on February 18, 2026 for 5.15%.

It may be further noted that the schemes/investment strategies of the Fund have carried out net acquisition of 2,03,22,019 shares of the Company from the last filing submitted on February 18, 2026 (for positions held as on February 17, 2026).

The holding by schemes/investment strategies of the Fund are from an investment perspective and not with the objective of seeking any controlling interest.
