The error was inadvertent and has occurred while considering the effect of the subdivision of equity shares of the Company from face value of ₹10 each to ₹2 each. The number of pledged shares has changed due to the stock split; however, there is no change in the actual percentage of pledged holding, which continues to remain at **5.11%**.
