Kerala denies delay in Wayanad relief

Kerala Agriculture Minister T Siddique on Monday denied allegations of delays in disbursing financial assistance to victims of the July 7 landslide at the Anakkompoiyl-Mep-padi tunnel project site, saying the relief process was progressing without any slow-down.

Responding to allegations raised by some of the injured survivors, Siddique said the government had carried out disaster management operations at an unprecedented pace and ensured adequate medical care for those affected. "The relief and compensation process is progressing smoothly, and follow-up treatment for the injured is being provided at their respective hospitals," he told reporters.

"Financial assistance to the families of those who died is being disbursed, while steps are underway to release assistance for the injured. There is no delay in the process, and it will be completed soon," Siddique said.

Army joins relief efforts as floods lash Upper Assam

Incessant rains worsened the flood situation in Upper Assam on Monday, requiring the deployment of Army personnel to assist state agencies in relief and rescue operations, while rail traffic was hit in the region with several trains rerouted, suspended or short-terminated.

According to the Assam State Disaster Management Authority (ASDMA), five people have died so far in this year's floods. More than 57,100 people in Charaideo, Dhemaji, Dibrugarh, Jorhat, Sivasagar, Tinsukia and Udalguri districts have been affected by the deluge, it said.

Several tea estates in the state are under floodwaters, with the Assam unit of the Tea Association of India saying that rivers from Nagaland



have swelled suddenly and were flowing above the danger level.

The breach of the embankment on the Dorika River aggravated the situation, inundating extensive stretches of the tea estates in the Nazira region, it said.

Northeast Frontier Railway said that due to heavy rainfall, the swollen Dikhow river flooded Simaluguri town in Si-

vasagar district in Tinsukia Division.

"Floodwaters have entered the station yard and the railway colony. Railway tracks in the area have also been inundated. For passenger safety, train movement in the Simaluguri-Namtiali and Simaluguri-Selenghat sections has been suspended until further notice," it said.

Long-distance trains from

Dibrugarh and Tinsukia have been diverted through the Rangiya-Rangapara route on the north bank of the Brahmaputra while several local trains have either been cancelled or short-terminated.

Chief Minister Himanta Biswa Sarma said four of his cabinet colleagues are on the ground and monitoring the rescue and relief operations. He has asked all MPs and MLAs of the affected districts to be at the flood-hit areas to oversee the rapidly changing situation.

"In Sivasagar, 510 people have been rescued by SDRF and the Fire and Emergency Services. Rescue efforts continue with additional boats and Army helicopters deployed to reach inaccessible areas," the Chief Minister's office posted on social media.

7 killed as landslide buries homes in Poonch

Jammu: At least seven people were reported dead after a landslide hit civilian houses in the Loran area of Poonch in Jammu and Kashmir.

Of the seven victims, eight has been identified as Tanvir Ahmed, 27, Zahida Begum, 38, Shameema Akhtar, 33, Shabnam Akhtar, 31; Mohd Irfan, 17; Manan Rafiq, 6; and one female whose name is unknown yet. The IMD has warned that the intense rainfall could trigger flash floods, overflowing streams, waterlogging in low-lying areas and localised flooding. Authorities have advised people to stay updated with weather advisories and avoid venturing into vulnerable areas during periods of intense rain.

SC: CBSE must amend APAAR consent forms

The Supreme Court on Monday said it will direct the CBSE to implement a direction of the Orissa High Court to amend the model consent form for the generation of Automated Permanent Academic Account Registry IDs to provide parents with the option to refuse consent or opt out of the scheme.

Under the Automated Permanent Academic Account Registry (APAAR) scheme, launched by the Ministry of Education under the New Education Policy, 2020, a unique, lifelong 12-digit student ID is generated. It acts as a digital passport for all educational records, securely storing mark sheets, degrees and co-curricular achievements in one place.

A bench comprising Chief Justice of India (CJI) Surya Kant and Justices Joymalya Bagchi and V Mohana was hearing a plea filed by the parents of four students challenging the validity of the APAAR ID scheme for students on the ground that it compelled them to obtain Aadhaar IDs.

The top court said that since the Centre has not challenged the high court's December 2025 judgement, it would direct the Central Board of Secondary Education (CBSE) to implement the ruling nation-

wide.

"We will direct the CBSE to implement this judgement on a pan-India basis, as the High Court order has been accepted. We are directing the CBSE to examine the issues as well," the bench said.

It said a formal order would be uploaded later.

The court also indicated that it would ask the CBSE to address concerns relating to consent and data protection raised by the petitioners.

Senior advocate Indira Jaising, appearing for the petitioners, said that children were being effectively compelled to enrol under a non-statutory scheme despite the government's description of APAAR as voluntary.

She said that while APAAR is projected as optional, it is linked to Aadhaar, making Aadhaar enrolment a practical prerequisite for obtaining an APAAR ID. Referring to the 2019 Aadhaar judgement in the K S Puttaswamy case, she said that children cannot be compelled to obtain Aadhaar and that making APAAR necessary for examinations indirectly violates that principle.

Karnataka sets 11 criteria for resident certificates

The Karnataka government has framed 11 eligibility criteria for issuing Permanent Resident Certificates (PRCs) in the backdrop of the Election Commission of India's (ECI) Special Intensive Revision (SIR) of electoral rolls and growing discussions surrounding residency. Deputy Chief Minister and Revenue Minister G. Parameshwara said on Monday.

The announcement was made during the launch of the state's doorstep delivery service for free caste certificates and Permanent Resident Certificates amid controversy at the Vidhana Soudha Conference Hall. The initiative was inaugurated by Chief Minister D.K. Shivakumar and Dy CM Parameshwara. Chief Minister Shivakumar stated that the Permanent Residence Certificate is one of the 11 documents recognised by the Election Commission for inclusion in electoral rolls.

Speaking at the event, Dy CM Parameshwara said the move marks another step towards citizen-centric governance, with the Karnataka government aiming to ensure that key documents reach beneficiaries without requiring repeated visits to government offices.

According to the Karnataka government, PRCs will be issued based on factors including birth in Kar-



nataka, employment, marriage, and continuous residence in the state for at least 10 years. Applicants who satisfy any of the prescribed criteria will be eligible to receive the certificate, he stated.

Nearly 4.85 crore caste certificates have been identified for distribution, including 1.36 crore beneficiaries under Categories 2A, 2B, 3A and 3B, 86 lakh under Category 1, and 2.63 crore Scheduled Caste and Scheduled Tribe certificate holders.

Jammu and Kashmir Chief Minister Omar Abdullah on Monday led a National Conference protest in Delhi seeking restoration of statehood to Jammu and Kashmir following the abrogation of Article 370 in 2019.

Omar, who initially flew back to Jammu to monitor the relief and rescue operation following flash floods, returned to the national capital and joined his party legis-

lators, who had already assembled outside JK House. The J&K CM was seen sitting beside Delhi Police barricades holding a placard reading "Restore rights and dignity of people of J&K".

In a post on X, Omar said that they were stopped from getting to Jantar Mantar and "stopped from protesting peacefully for what is rightfully ours but we were not silenced".

"This is only the beginning of our struggle for statehood, our rights, our dignity and



everything that was taken away from us," he wrote. The demonstration attended by senior party leaders including NC
