militants killed

Following the failed suicide bombing attempt at the Kari Kot post, an exchange of fire took place between security forces and the attackers, during which four militants, including the suicide bomber, were killed. The militants were affiliated with 'Ftina al-Khawarji', police said, referring to the term the State uses for the outlawed Tehreek-e-Taliban Pakistan (TTP) and its affiliates. No casualties were reported among security forces during the operation, according to officials. Security officials said a search and clearance operation is underway in the area to trace and eliminate any remaining militants. (AP)
