The Power of Performance

For four decades, Shilchar Technologies has built a legacy rooted in quality, customer-centric solutions, technological depth, and efficient manufacturing. This focus has earned the trust of customers across the utility, industrial, and renewable energy sectors, in India and around the globe.

In FY26 as well, the Company delivered growth in revenue and profitability, crossing ₹650 crore in revenue for the first time, even as the closing quarter brought external headwinds that were beyond its control. US tariff uncertainty earlier in the year and the crisis in West Asia later in the year temporarily slowed export dispatches and created operational challenges, **but the underlying demand for transformers remained firm across every geography we serve.**

Over the past five years, revenue, EBITDA, and profit after tax have compounded at 38%, 77%, and 83% respectively, a record that reflects the durability of our business model and our ability to capture opportunities. The year was also defined by a decisive step forward. We commenced the largest capacity expansion in our history, a new 6,500 MVA facility at Gavasad that will

take installed capacity to 14,000 MVA and add 220 kV class capability to our product range for the first time.

As global energy infrastructure draws record investment, Shilchar's transformers continue to sit at the heart of the systems that power industries and the renewable energy transition. With a robust debt-free balance sheet, a healthy order pipeline for FY27, and a clear roadmap for growth, we are positioned to deliver full utilisation of our capacity in FY27 and to bring new capacity onstream from FY28.

"The Power of Performance" remains at the core of how we create value for our stakeholders.



From the Chairman's Desk

Investing in the Next Phase of Growth

Dear Shareholders,

It is my pleasure to present Shilchar Technologies' Annual Report for FY26, a year that proved both rewarding and, in its final quarter, testing. We crossed ₹650 crore in revenue for the first time, delivered another year of strong profitability, and launched the largest capacity expansion project in the Company's history. A softer fourth quarter, caused by external headwinds that were temporary and are now largely behind us, did not change the strength of the business momentum or the direction we are taking. Above all, FY26 was the year we committed to the next phase of our growth, and this letter sets out both what we achieved and the investments we are making for the years ahead.

Our Demand Outlook

The decision to expand was a direct response to what we see in our markets. Demand for transformers strengthened steadily through the year, driven by sustained investment across power generation, transmission, and distribution. Rising electricity consumption, the modernisation of the grid, and the utility-scale shift to renewable energy all supported this momentum. India added a record 55 GW of renewable capacity in FY26, and that build-out kept order inflows healthy for our renewable transformer business, where we supply inverter duty transformers for solar projects and generator transformers for wind projects. Our export markets were equally firm. The replacement of ageing grids, a global shortage of transformer supply, and growing private investment in data centres for AI all added to demand, and with supply tight, customers continued to favour established suppliers like Shilchar. Across both our domestic and export businesses, the structural picture remains one of robust and durable demand.

Financial Performance

Against this backdrop, our full-year performance was healthy. Revenue from Operations grew about 5% to ₹652 crore, EBITDA was ₹190 crore at a margin of 29%, and Profit After Tax rose 8% to ₹158 crore, with Earnings Per Share of ₹138 on a post-bonus basis. Seen over a longer horizon, the consistency of our execution is clearer still: across the past 5-years, revenue, EBITDA, and profit after tax have compounded at 38%, 77%, and 83% respectively. These outcomes reflect both the strength of our business and the discipline we maintain across design, procurement, and production.

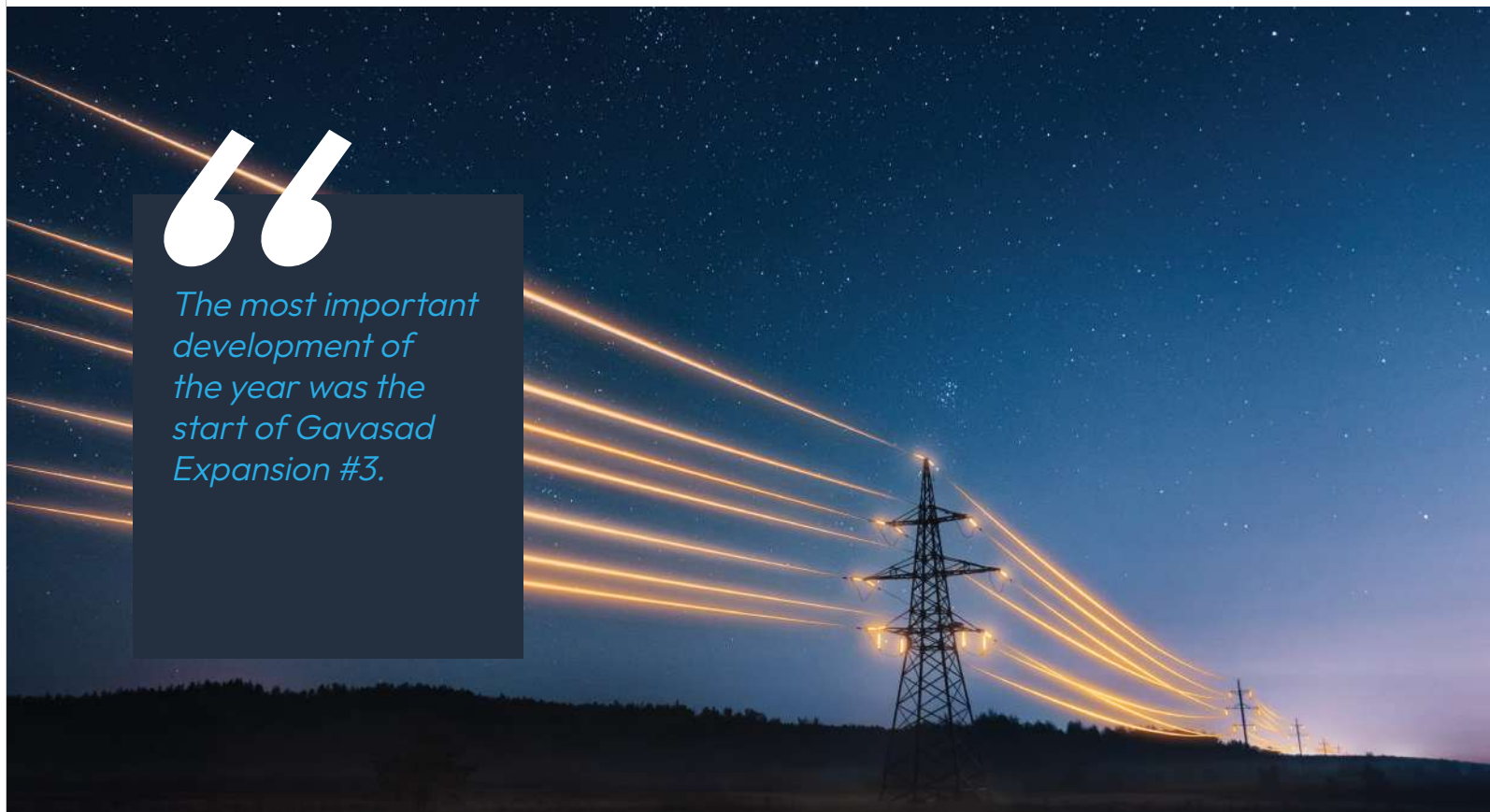
The Fourth Quarter

Within FY26, the fourth quarter was softer than we had expected, and I want to detail the reasoning for it. Revenue for the quarter was ₹152 crore, with an EBITDA margin of 21% and Profit After Tax of ₹28 crore. Two external developments shaped this outcome, and both were temporary.

The first was a period of uncertainty around United States tariff policy, which moderated order intake from our US customers during the third quarter. Inflows recovered through the fourth quarter, but because the preceding intake had been lower, dispatches in the quarter remained slow. With tariff policy since amended and our US customers signalling firm demand, both order intake and deliveries have picked up in the first quarter of FY27.

The second was the crisis in West Asia. A significant volume of shipments scheduled for our Middle East customers in March could not move, as the conflict disrupted shipping routes, and some of these were deferred to later quarters. Dispatches to the region resumed in April and have improved gradually since.

These two developments also weighed on our margin for the quarter. Exports carry a higher margin for us, so their lower share in the quarter changed our sales mix and pulled the margin down. Commodity prices added to the pressure, with a sharp rise in transformer oil prices during March. The cost increase is well understood across the industry, and we expect to recover it over the coming quarters, while new inquiries are already being quoted at prices that reflect current input costs.

A Strong Balance Sheet

None of this changed the financial strength that defines the business. Shilchar remains debt-free, with cash and cash equivalents of ₹246 crore at the close of FY26 and operating cash flow from operating activities of ₹192 crore for the year. That strength allows us to fund our entire expansion programme from internal accruals, without relying on external borrowings. During the year we also gave effect to a bonus issue of one equity share for every two held, and for FY26 the Board has recommended a final dividend of ₹12.50 per share, subject to shareholders approval.

Investing in the Next Phase

The most important development of the year was the start of Gavasad Expansion #3. The new facility will add 6,500 MVA, taking our total installed capacity to 14,000 MVA, and will extend our capabilities into the 220 kV class products for the first time. That step matters, because it opens the larger market for higher-voltage power transformers and widens the base of customers we can serve. The capital outlay is ~₹120 crore, again funded entirely through internal accruals. Work is well advanced: civil foundations are complete, the pre-engineered building and utility infrastructure are in progress, and all major production equipment has been ordered, keeping the facility on track for commissioning in April 2027.

Our capacity plan from here is straightforward. In FY27, we expect to run our existing 7,500 MVA at close to full

utilisation as demand holds firm and exports return to normalcy. The new capacity then comes onstream in April 2027 and will drive the next phase of growth from FY28, as approvals for the higher voltage classes are secured and the new lines fill with orders. More importantly, the Gavasad site has further land available beyond 14,000 MVA, which means we can keep adding capacity at the same site as demand grows.

Outlook

We therefore enter FY27 from a position of strength, with an order book of ₹452 crore and order visibility for the year of ~₹800 crore, supported by inquiries from both domestic and export customers. The demand outlook across power transmission, distribution, and renewable energy remains favourable. With the export disruptions behind us and price revisions underway, we are confident of returning to our normal growth trajectory from early in the year, and of building from there as our new capacity comes online.

In closing, I thank our employees for their commitment through a demanding year, our customers for their continued trust, and you, our shareholders, for your support. We will continue to build Shilchar with discipline and a long-term view, and to create lasting value for everyone who has a stake in our journey.

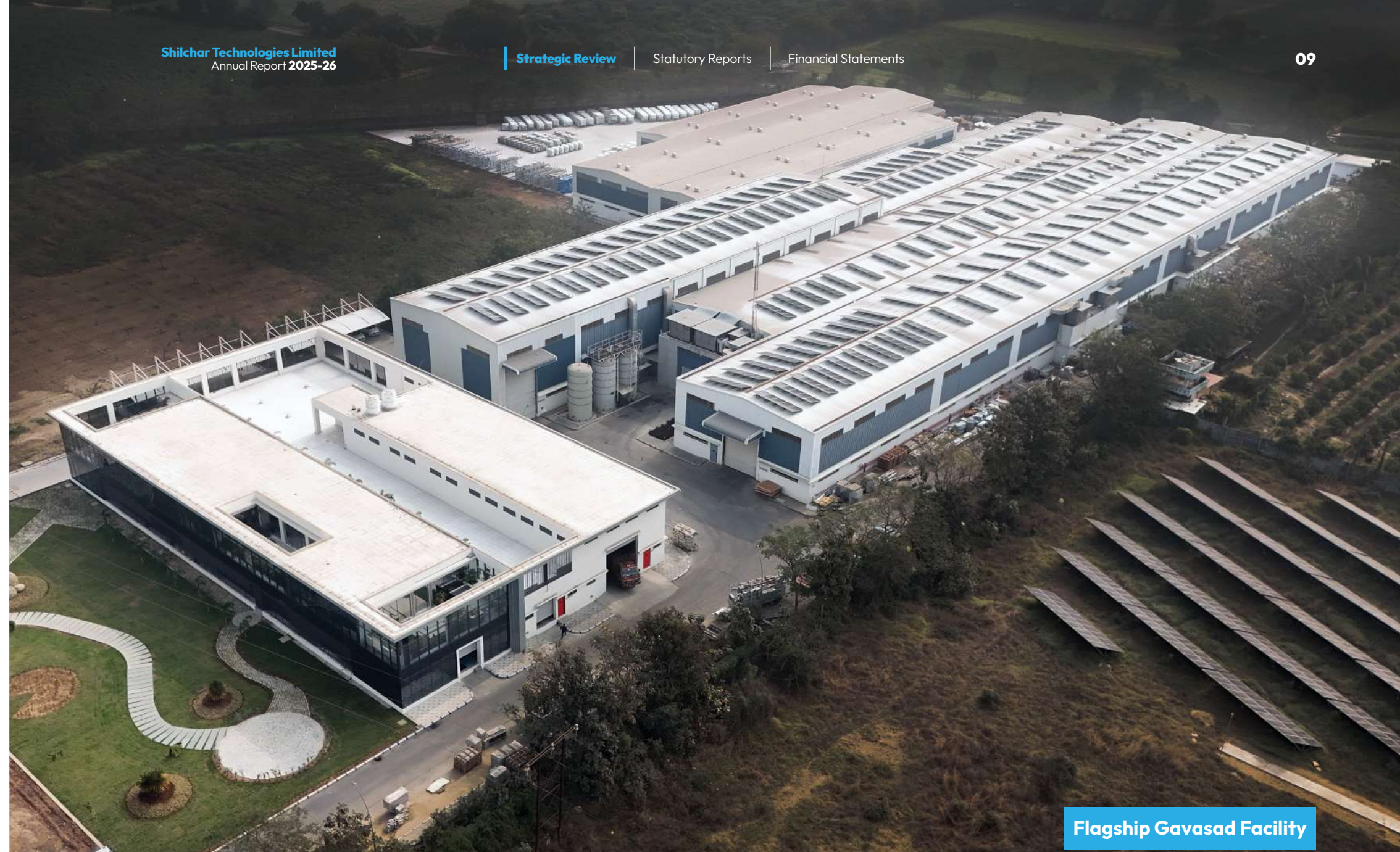

Shilchar Technologies' manufacturing operations reflect its dedication to quality and efficiency. Every stage of production is designed and executed to deliver high-quality transformers that meet the needs of domestic and international markets. The Company's focus on innovation, precision, and operational synergy forms the backbone of its manufacturing philosophy and underpins its ability to deliver on demanding customer-specifications.



Flagship Gavasad Facility

Inside the Gavasad Facility

Located near Vadodara, Gujarat, Shilchar's flagship facility at Gavasad spans an expansive 17-acre plot, with ample room for future expansions, one of which is currently underway. Following the capacity increase commissioned in August 2024, the facility's annual production capacity stands at 7,500 MVA which is set to expand to 14,000 MVA in April 2027, enabling Shilchar to serve growing market demand. The existing built-up area of about 1.6 lakh sq. ft. is being supplemented by a further 1.1 lakh sq. ft. as part of the ongoing expansion.

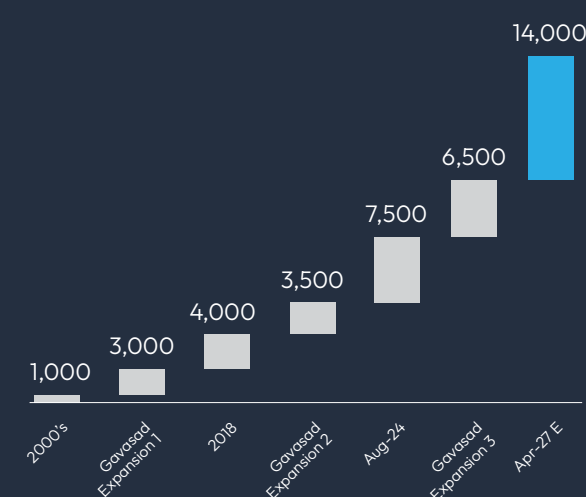
All operations from the old Bil facility have been consolidated into Gavasad since 2024, improving synergy and oversight. The facility houses dedicated production shops with layouts tailored to specific product categories:

- 5 MVA, 33 kV class transformers
- 50 MVA, 132 kV class transformers
- Distribution transformers
- 220 kV class transformers - upcoming

The Next Capacity Leap

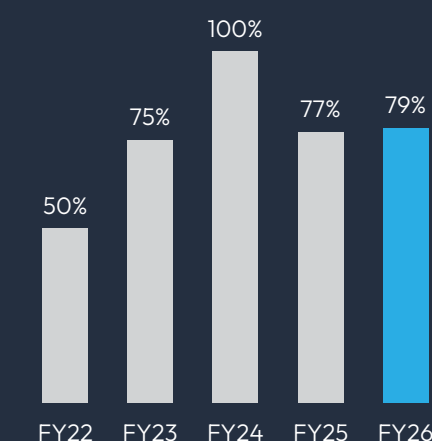
Gavasad Expansion #3, the largest in the Company's history, will add 6,500 MVA to take total installed capacity to 14,000 MVA. The new facility will also extend Shilchar's capability into the 220 kV class, supporting larger power transformers and a wider customer base. The project carries a capital outlay of approximately ₹120 crore, funded entirely through internal accruals. Civil foundation work is complete, structural and utility infrastructure work is in progress, and all major production equipment has been ordered. The facility remains on track for commissioning in April 2027 and will begin contributing from FY28, with the higher voltage classes production ramping up as customer approvals are secured. Meanwhile the facility will cater to the existing product portfolio of the Company.

Operations Built on Precision

Shilchar's operations are powered by a skilled workforce of over 475 employees and strong technical capabilities. The Company uses integrated ERP systems such as SAP to streamline workflows from customer inquiry to final shipment, and tools such as Solid Edge for 3D design to support accuracy during product development.

The process spans engineering, procurement, production, and testing, ensuring every transformer meets stringent quality standards while adhering to customer-specific requirements at each stage.



Infrastructure That Delivers

The facility is designed for precision engineering, cleanliness, and efficiency. A dust-free environment is maintained through positive air pressure from an advanced HVAC system and epoxy flooring across the plant. A dedicated winding shop with PLC-based automatic foil winding machines and argon gas-based brazing ensures precision at critical stages.

Material storage is integrated with SAP ERP for traceability and identification, and the facility houses a NABL-accredited testing laboratory equipped to conduct routine, special, and type tests as per IS 2026 and IEC 60076 standards.

As an ISO-certified organisation with NABL-accredited facilities, the Company adheres to the parameters set by IS and IEC guidelines. The testing infrastructure includes an in-house impulse generator capable of chopping up to 900 kVp/90 kJ and high-voltage testing equipment up to 300 kV/1 Amp.

A partial discharge-free testing lab supports transformers up to the 132 kV class, while three testing laboratories enable simultaneous testing to improve throughput. These capabilities ensure that every transformer leaving the facility is reliable, efficient, and built to last.

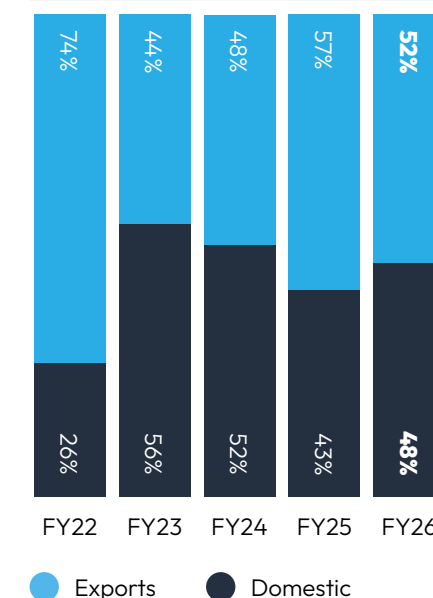

The total income increased by 6% to ₹ 67,798.61 Lakhs in comparison to ₹ 63,961.75 Lakhs of Previous Financial Year 2024-2025.

EBIDTA:

The EBIDTA increased by 8% to ₹ 21,646.48 Lakhs in comparison to ₹ 20,121.63 Lakhs of Previous Financial Year 2024-2025.

PAT:

MANAGEMENT DISCUSSION AND ANALYSIS

ECONOMIC OVERVIEW

Global economy

The global economy enters 2026 under the shadow of a new geopolitical shock. The outbreak of war in the Middle East at the end of February 2026 has emerged as a significant counterforce to the global economic tailwinds that had supported growth over the past year, specifically technology-related investment, accommodative financial conditions including a weaker US dollar, and fiscal and monetary policy support. The IMF's April 2026 World Economic Outlook presents a "reference forecast" built on the assumption that the conflict remains limited in duration and scope, with disruptions fading by mid-2026.

Under this reference forecast, global growth is projected at 3.1% in 2026 and 3.2% in 2027, below the 2024–25 pace of approximately 3.4%, and well short of the pre-pandemic historical average of 3.7%. Global headline inflation is expected to rise to 4.4% in 2026 before easing to 3.7% in 2027. The IMF notes that if not for the conflict, 2026 growth would have been revised marginally upward; the downward revision is therefore largely a product of Middle East crises, partly offset by carryover from strong recent data and reduced tariff rates.

The impact is uneven across economies. Advanced economies have seen broadly unchanged growth forecasts, while emerging market and developing economies face a 0.3 percentage point downward revision for 2026, with commodity-importing nations and more vulnerable economies carrying a disproportionate burden. Under more adverse scenarios involving larger or more persistent energy price shocks, global growth could fall as low as 2.0% in 2026, with headline inflation breaching 6.0% by 2027.

The IMF identifies a range of downside risks beyond the immediate conflict: further escalation of trade tensions, a correction in AI-related investment valuations, fiscal deterioration across sovereigns already operating with limited buffers, and erosion of central bank credibility at a time when inflation expectations are already under pressure. On the upside, a sustained AI productivity dividend and renewed momentum on structural reforms could provide meaningful support to economic activity.

Indian economy

Despite heightened global trade tensions, and geopolitical shocks, India retained its position as the fastest-growing major economy in FY26. Real GDP growth accelerated to 7.6%, up from 7.1% in FY25, driven by robust domestic demand underpinned by low inflation, income tax cuts, GST rationalisation, and more accommodative monetary conditions. Manufacturing and services both delivered strong supply-side performance. The current account deficit narrowed to 1.0% of GDP, and fiscal consolidation continued, bringing the general government deficit down to 7.4% of GDP.

Labour market conditions remained stable. Formal employment creation strengthened, with net new EPF subscribers growing at nearly 14% year-on-year in the first half of FY26. Headline inflation averaged just 1.9% between April 2025 and February 2026, compared to 4.7% in the same period of FY25, driven primarily by a sustained fall in food prices. The RBI responded by cutting the policy rate by a cumulative 125 basis points to 5.25%, before shifting its monetary policy stance from accommodative to neutral in June 2025 as the room for further easing narrowed.

The external position came under pressure in the latter part of FY26. The Indian rupee depreciated against the US dollar, falling to an all-time low of approximately ₹ 95/USD by end-March 2026, driven by foreign portfolio outflows and heightened financial market volatility following the onset of the Middle East crises. Foreign exchange reserves declined to \$698 billion by end-March, from a peak of nearly \$730 billion in late February.

Looking ahead, the World Bank projects India's FY27 growth at 6.6%, reflecting headwinds from elevated global energy prices and supply chain disruptions associated with the Middle East conflict. Higher oil and gas import costs are expected to raise inflationary pressures, temper private consumption, and widen the current account deficit to approximately 1.8% of GDP. A prolonged conflict poses additional risks, particularly given India's reliance on Gulf remittances, which account for approximately 38% of total inward remittance flows. Should global energy markets normalize, growth is expected to rebound to 7.2% in FY28.

India's macroeconomic buffers remain a meaningful source of resilience. The World Bank highlights that the current environment underscores the importance of energy diversification, prudent fiscal management, and advancing trade diversification through recently concluded and prospective free trade agreements, priorities that will strengthen India's position in an increasingly fragmented global trade environment.

INDUSTRY OVERVIEW

Global transformer industry

The global transformer industry is in a sustained growth phase, shaped by the convergence of electrification, renewable energy integration, grid modernisation and the replacement of ageing transmission and distribution assets. Transformers have evolved from a passive grid component into a strategic asset at the centre of the energy transition, with utilities, industrial operators and data-centre developers all driving parallel demand for more efficient and reliable equipment. Industry estimates value the overall transformer market at around USD 65 billion in 2025, with expectations of it reaching close to USD 88 billion by 2030, reflecting a CAGR of approximately 6.5%. Asia-Pacific remains both the largest and fastest-growing region, supported by large-scale grid build-outs in markets such as India and China, while North America and Europe continue to scale investment to modernise networks, connect renewables and meet rising electricity demand.

A defining feature of the current cycle is a structural tightening of supply. Years of under-investment in manufacturing capacity, set against a sharp rise in demand from renewable connections, electrification of transport and industry, and the rapid expansion of data centres, have stretched delivery timelines and prompted buyers to secure production slots well in advance through multi-year supply agreements. The demand impulse from digital infrastructure is particularly notable, with the growth of artificial-intelligence-led data centres expected to add materially to transformer requirements over the coming years, while global electricity demand is set to rise far faster than overall energy demand as electrification accelerates. This combination of firm demand and constrained supply has supported pricing and lengthened order books across the industry.

For Indian manufacturers, this environment represents a meaningful opportunity. A worldwide shortage of transmission and distribution equipment, the build-out of feeder factories by global original equipment manufacturers that increasingly use India as a production base, and the growing credibility of Indian players in higher voltage classes are together enabling domestic producers to integrate

into global supply chains and scale up exports, often at realisations superior to the domestic market.

Indian transformer industry

The Indian transformer industry is undergoing a sustained period of growth, underpinned by the country's large transmission and substation build-out, rising renewable integration, distribution-network upgrades and the emergence of new demand verticals. Transformers remain critical to India's evolving power sector as the nation works to meet rising energy needs while transitioning towards a cleaner and more efficient grid.

This growth is fuelled by several key drivers:

1. **Transmission and Substation Build-out:** The National Electricity Plan for FY23 to FY32, prepared by the Central Electricity Authority, envisages transmission investment of close to ₹ 9.2 lakh crore and provides for the addition of more than 191,000 circuit kilometres of transmission lines and 1,270 GVA of transformation capacity at the 220 kV and above voltage level over the decade, directly expanding the addressable market for power transformers.
2. **Renewable Energy Integration:** The drive towards 500 GW of non-fossil-fuel capacity by 2030 is increasing demand for specialised transformers capable of managing the variable inputs associated with solar and wind generation while maintaining grid stability.
3. **Distribution Network Upgrades:** Continued investment under the Revamped Distribution Sector Scheme is strengthening last-mile networks across urban and rural areas, sustaining demand for distribution transformers and supporting the broader electrification drive.
4. **Emerging High-Growth Verticals:** Data centres, electric-vehicle charging infrastructure, green hydrogen, battery storage and railway electrification are creating incremental demand for high-capacity, low-loss transformers, broadening the demand base beyond the conventional transmission build-out cycle.
5. **Replacement and Modernisation Demand:** The replacement of ageing assets and the migration towards higher voltage classes continue to generate demand across both new capacity additions and refurbishment, reinforcing the structural nature of the growth.

This momentum is already visible in equipment demand, with the IEEMA electrical-equipment growth index rising around 14% year-on-year in the first half of FY26, led by strong growth in power transformers. At the same time, limited capacity additions over the preceding years have created a demand-supply mismatch in the higher voltage classes, firming pricing in particular across the 400 kV and 765 kV ranges. In response, domestic transformer manufacturing capacity is expanding materially, with industry estimates pointing to total capacity rising from around 375 GVA in FY25 towards approximately 690 GVA by FY28 as leading players commission new lines. In the near term, sector-level ordering moderated during FY26, owing primarily to

execution-bandwidth constraints and the longer lead times associated with the transition to higher-kV equipment; this moderation is regarded as transient rather than a reflection of any structural weakness in underlying demand.

Sectoral Trends

- **Power Transformers:** Seeing firm demand from high-voltage transmission projects, renewable energy parks and cross-regional transmission corridors as grid investment accelerates.
- **Distribution Transformers:** Remaining critical for last-mile connectivity and network strengthening under schemes such as the Revamped Distribution Sector Scheme.
- **Converter Transformers:** Gaining traction as high-voltage direct current systems are increasingly deployed for long-distance transmission and the efficient evacuation of renewable energy.

Challenges Facing the Industry

- **Raw Material Price Volatility:** Movements in the prices of cold-rolled grain-oriented steel and copper can affect profitability, though much of the impact is mitigated through variable pricing contracts linked to the IEEMA index.
- **Supply-Chain Lead Times:** Extended lead times for critical inputs and components can influence project timelines.
- **Regulatory Compliance:** Meeting stringent quality and regulatory requirements adds to production complexity and cost.
- **Execution Bandwidth:** The shift towards higher-voltage equipment, while positive for value, may continue to influence the pace of order execution in the near term.

Opportunities Ahead

- **Energy-Efficient Transformers:** A growing emphasis on efficiency is increasing the adoption of low-loss and environmentally compliant transformers.
- **Smart Grid Technologies:** The deployment of smart grids is creating demand for advanced, monitoring-enabled equipment with real-time diagnostics.
- **Export Potential:** As Indian manufacturers build capability in the 400 kV to 765 kV range to utility-grade standards, they are strengthening their position across Africa, the Middle East, Southeast Asia and parts of Latin America, supported by a global shortage of T&D equipment, recent trade agreements and export realisations that typically exceed domestic levels.
- **Infrastructure Modernisation:** The modernisation of ageing transmission and distribution infrastructure under the broader electrification and "Make in India" agenda continues to expand the addressable market across all segments.

INDIA POWER SECTOR

India's power sector remains central to the country's economic growth and its energy-transition commitments, with sustained investment flowing into transmission build-out, grid modernisation and storage, and with the role of private capital expanding meaningfully.

Transmission and Distribution Infrastructure

The National Electricity Plan for FY23 to FY32 has laid out a transmission investment programme of close to ₹ 9.2 lakh crore, of which approximately ₹ 4.25 lakh crore is planned over FY22 to FY27 and a further ₹ 4.91 lakh crore over FY28 to FY32. This plan is designed to evacuate 500 GW of renewable capacity by 2030 and support over 600 GW of installed capacity by 2032. Installed transformation capacity at 220 kV and above is expected to grow from around 1,451 GVA in FY26 to approximately 2,412 GVA by FY32, a compound annual growth rate of close to 9%, while the transmission line network at the same voltage levels is planned to expand at a compound annual growth rate of around 4% through FY32. Growth is most pronounced at the higher voltage classes, with 765 kV substation capacity projected to roughly triple by FY32 and inter-regional transmission capacity targeted to rise towards 168 GW by 2032.

A significant structural shift within this build-out is the rising role of private capital. Under the Tariff Based Competitive Bidding framework, projects worth approximately ₹ 1.03 lakh crore had been commissioned since the framework's inception as of March 2026, with private developers contributing close to half of the total capital deployed. Calendar year 2025 marked a series of landmark developments in this regard, including the first private-sector high-voltage direct current award under the framework and a growing share of the commissioning pipeline shifting towards private players, reflecting the maturing of a competitive and institutionally-backed model for scaling India's transmission infrastructure. On the distribution side, the Revamped Distribution Sector Scheme, with an outlay of around ₹ 3 lakh crore, continues to drive network upgrades, although elevated aggregate technical and commercial losses in some states and the financial position of state distribution companies continue to weigh on investment in modernisation.

Energy Storage

The plan also factors in significant storage requirements to support the integration of variable renewable generation, including 47 GW of battery energy storage and 31 GW of pumped storage. Policy support, including viability gap funding for standalone battery storage projects, has improved the cost-competitiveness of storage and accelerated project awards, with a growing pipeline of standalone and co-located battery tenders issued by central and state agencies over the past year.

Challenges Facing the Sector

- **Grid Integration:** The variability and intermittency of solar and wind generation pose challenges for grid stability.
- **Energy Storage:** Large-scale deployment of storage, though accelerating, remains capital-intensive.

- **DISCOM Financial Health:** Elevated AT&C losses and the financial position of state distribution companies continue to constrain investment in distribution modernisation.
- **Execution Bandwidth:** Sector ordering has seen a temporary moderation owing to execution capacity and the transition to higher-voltage equipment, even as underlying demand remains strong.

INDIAN RENEWABLE ENERGY SECTOR

India's renewable energy sector continues to anchor the country's clean-energy transition, supported by ambitious capacity targets, policy continuity and rising private investment. The country is working towards 500 GW of non-fossil-fuel capacity by 2030, with solar and wind forming the core of this expansion, and over 600 GW of total installed capacity by 2032. FY26 marked a record year for renewable additions, with approximately 55 GW of capacity commissioned, reflecting the accelerating pace of solar and wind deployment and reinforcing the medium-term demand outlook for renewable-application transformers.

This momentum has direct implications for the transformer industry. The variable nature of solar and wind generation requires specialised transformers capable of managing fluctuating inputs while maintaining grid stability, sustaining demand for inverter-duty, generator and related renewable-application transformers. The parallel build-out of storage infrastructure, alongside emerging segments such as green hydrogen, further broadens the range of grid-supporting equipment required over the coming years.

Policy Support and Government Initiatives

Policy continuity remains a key enabler of sector growth:

- **Renewable Purchase Obligations (RPOs):** Mandate state utilities to procure a specified share of their electricity from renewable sources.
- **Production Linked Incentive (PLI) Scheme:** Supports domestic manufacturing of high-efficiency solar modules and reduces import dependence.
- **Green Energy Corridor:** Facilitates the integration of renewable energy into the national grid through enhanced transmission infrastructure.
- **National Green Hydrogen Mission:** Positions India as a hub for green hydrogen and opens new avenues of long-term demand for power infrastructure.

Conclusion

India's power and renewable energy sectors continue to present a structurally favourable environment for the transformer industry. Sustained investment in transmission and distribution infrastructure, a record pace of renewable capacity addition, and the expansion of storage and emerging demand verticals together underpin strong and durable demand visibility for the years ahead, positioning

well-placed domestic manufacturers to benefit across both the home and export markets.

Today, we produce transformers up to 50 MVA and 132 KV class.

Our manufacturing facility in Gavasad spans 17 acres, with an annual production capacity of 7,500 MVA, expanding by an additional 6,500 MVA in April 2027. We serve diverse applications including renewable energy, industrial needs, and specialised solutions. Our transformers support solar, wind, and hydro power generation, as well as furnace and converter duty applications, meeting domestic and international energy requirements. Each product is designed for precision engineering, technology integration, and long-term reliability.

Shilchar Technologies operates in over 25 countries across five continents. Exports contribute more than 48% of our revenue, reflecting strong customer relationships and quality reputation. Financially, we maintain a zero-debt balance sheet, substantial cash reserves, and industry-leading profitability and return ratios. These enable strategic investments in growth, capacity expansion, and technology.

Our operations prioritise quality, sustainability, and employee well-being. We hold ISO 9001:2015 for Quality

Management, ISO 14001:2015 for Environmental Management, and ISO 45001:2018 for Occupational Health and Safety certifications. As a zero-discharge pollution unit, we continue to improve environmental stewardship while optimising manufacturing efficiency.

We are positioned to benefit from rising global transformer demand, driven by infrastructure investments, electrification, and the shift to renewable energy. With planned capacity expansions, we aim to scale manufacturing capabilities to 25,000-30,000 MVA in the coming years. Shilchar Technologies remains committed to delivering value to stakeholders and supporting a sustainable, energy-efficient future.

FY26 PERFORMANCE REVIEW

Shilchar Technologies Limited continued its growth trajectory in FY26, with Revenue from Operations rising to ₹ 651.94 Crores, an increase of around 5% over ₹ 623.15 Crores in FY25. EBITDA (excluding Other Income) stood at ₹ 190.42 Crores, up 3% from ₹ 184.75 Crores in the previous year, while the EBITDA margin moderated marginally to 29.2% from 29.6% in FY25. Profit After Tax grew 8% to ₹ 158.16 Crores, compared with ₹ 146.85 Crores in FY25, and Earnings Per Share, restated for the bonus issue, improved to ₹ 138.25 from ₹ 128.37. The Company sustained close to 79% utilisation of its 7,500 MVA capacity during the year and retained its debt-free balance sheet with substantial cash reserves.

The year closed on a softer note, as dispatches in the fourth quarter were affected by two external and temporary factors, namely the interim uncertainty around US tariff policy that moderated order intake from US customers, and the logistics disruptions arising from the crisis in West Asia that deferred certain shipments to Middle East customers. Both factors were temporary in nature, with order intake and deliveries picking up subsequently, and the Company expects to resume its growth trajectory ahead.

OUTLOOK

Looking ahead, Shilchar is well-positioned to capitalise on the growing Indian and global demand for transformers, driven by infrastructure development, rising electrification, and the accelerating shift toward renewable energy. Domestic demand has remained firm, supported by record renewable energy commissioning of around 55 GW in FY26 and a sustained national transmission build-out, both of which underpin strong demand visibility for the Company's renewable and distribution transformer offerings. On the export front, the recovery in US order intake following the tariff amendments and the normalisation of dispatches to the Middle East provide a more balanced foundation for international growth, while the Company continues to expand into newer geographies to broaden its base.

The Gavasad Expansion #3 project, which adds 6,500 MVA to take total capacity to 14,000 MVA by April 2027, will also enable Shilchar to enter the 220 kV class and address a larger segment of the market, with the expansion funded entirely through internal accruals. In FY27, the Company expects to operate at full utilisation of its existing 7,500 MVA capacity. With a debt-free balance sheet, healthy capital return ratios, and the temporary headwinds of the past year progressively easing, the Company's overall business outlook remains positive.

RISKS & CONCERNS

The geopolitical landscape, supply chain disruptions, and fluctuating commodity prices are critical factors affecting future business opportunities. Price volatility in raw materials poses a challenge, particularly for fixed-price transformer orders, as sudden cost increases can impact profitability. Exchange rate fluctuations of the Indian Rupee against the US Dollar affect margins, as key raw materials such as copper, transformer oil, and special steels for lamination are primarily imported. Managing these uncertainties is essential to ensure operational efficiency and financial stability.

EFFECTIVENESS OF INTERNAL CONTROL SYSTEMS

We have established internal control systems to safeguard assets, prevent unauthorised use or disposal, and ensure accurate authorisation, recording, and reporting of transactions. These controls optimise resource utilisation, enhance operational efficiency, and maintain oversight of

operations while ensuring compliance with applicable laws and regulations.

Our commitment to governance and financial integrity is supported by regular audits, with auditors confirming the adequacy and effectiveness of our internal controls. These measures strengthen our governance framework and ensure confidence in the accuracy, reliability, and transparency of our financial and operational activities.

HUMAN RESOURCE DEVELOPMENT AND INDUSTRIAL RELATIONS

At Shilchar Technologies, our employees are central to our success and growth. We offer training programmes to enhance their skills and expertise. Our goal is to attract and retain talent by creating a rewarding workplace.

We have built a collaborative and inclusive work environment that values communication, respect, and teamwork. Employee safety, well-being, and professional growth are priorities, and we integrate occupational health, safety, and environmental sustainability practices into our operations. Through planning, training, and execution, we maintain responsible and sustainable business practices.

During the year under review, we maintained our status as a 'Zero Discharging Pollution Unit'. As of March 31, 2026, our workforce comprised over 177 permanent employees and 300 indirect employees, reflecting our expansion and focus on human capital.

We believe that investing in our people and maintaining strong industrial relations will drive sustained success and long-term growth.

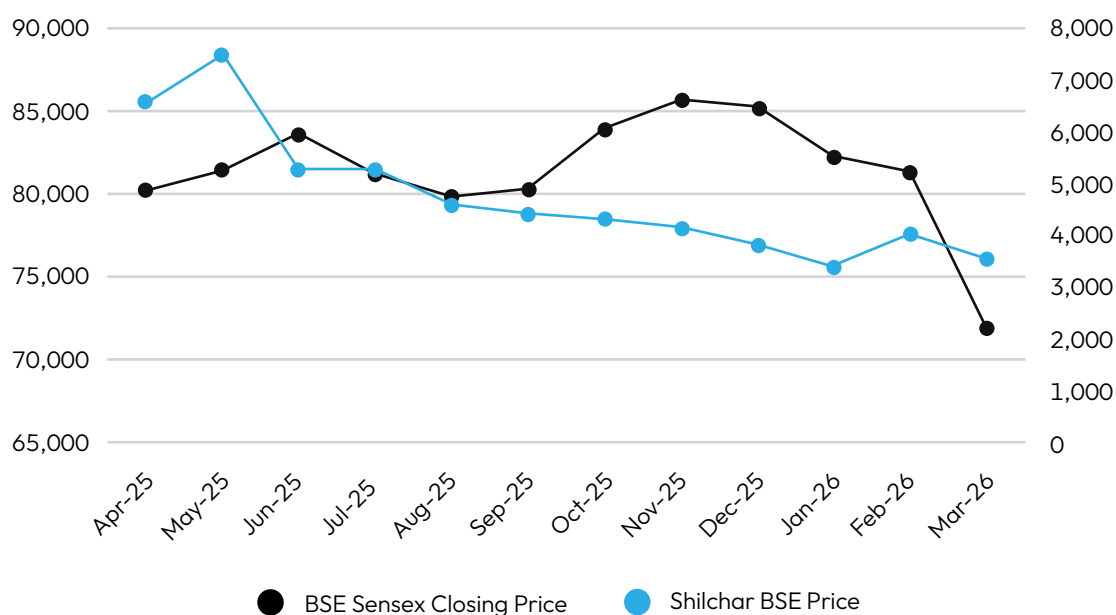

Notes Forming Part of The Financial Statements

1. COMPANY OVERVIEW AND MATERIAL ACCOUNTING POLICIES

1.1 Description of Business:

SHILCHAR TECHNOLOGIES LIMITED ("the Company"), incorporated in the year 1986 is Public Limited Company and engaged in the business of manufacturing of "Distribution & Power Transformers" as well "Electronics & Telecommunication Transformers."

The Company made its public issue in the year 1995 and is listed on Mumbai Stock Exchange.

1.2 Basis of Preparation of Financial Statements:

i. Compliance with Ind AS

The Financial statements of the Company have been prepared in accordance with Indian Accounting Standards (Ind AS) as prescribed under Section 133 of the Act to be read with Rule 3 of the Companies (Indian Accounting Standards) Rules, 2015 and the relevant amendment rules issued thereafter.

ii. Historical cost convention

The financial statements have been prepared on a historical cost basis, except the following:

- Certain financial assets and liabilities that are measured at fair value;
- Defined benefit plans – plan assets measured at fair value.

iii. Functional and presentation currency

These financial statements are presented in Indian Rupees, which is the Company's functional currency, and all values are rounded to the nearest Lakhs, except otherwise indicated.

iv. Composition of Financial Statements

The financial statements comprise:

- Balance Sheet
- Statement of Profit and Loss
- Statement of Cash Flow
- Statement of Changes in Equity
- Notes to Financial Statements

1.3 Key Accounting Judgments, Estimates and Assumptions:

In preparing these financial statements, management has made judgments, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets, liabilities, income and expense. Actual results may differ from these estimates.

Estimates and underlying assumptions are reviewed on an ongoing basis. Any change in these estimates and assumptions will generally be reflected in the financial statements in current period or prospectively, unless they

are required to be treated retrospectively under relevant accounting standards.

2.1 MATERIAL ACCOUNTING POLICIES AND OTHER EXPLANATORY NOTES

A. Property, Plant and Equipment:

i. Recognition and measurement

Freehold land is carried at cost and not depreciated. All other items of property, plant and equipment are measured at cost less accumulated depreciation and any accumulated impairment losses. Cost includes expenditure that is directly attributable to the acquisition of the items.

Income and expenses related to the incidental operations, not necessary to bring the item to the location and condition necessary for it to be capable of operating in the manner intended by management, are recognized in the Statement of Profit and Loss.

If significant parts of an item of property, plant and equipment have different useful life, then they are accounted and depreciated for as separate items (major components) of property, plant and equipment.

An Item of Property, Plant and Equipment is derecognized upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss on disposal of an item of property, plant and equipment is recognized in the Statement of Profit and Loss.

ii. Subsequent Expenditure

Subsequent expenditure is capitalized only if it is probable that the future economic benefits associated with the expenditure will flow to the Company.

iii. Depreciation

Depreciation is recognised so as to write off the cost of the assets (other than freehold land) less their residual values over their useful lives, using the Straight Line Method on the basis of useful lives specified in part C of Schedule II to the Companies Act, 2013 except plant and equipment ranging from 10 – 20 years. The Estimated useful lives, residual values and depreciation method are reviewed at the end of each reporting period, with the effect of any changes in the estimated accounted for on a prospective basis.

B. Investment Property:

Property that is held for long-term rental yields or for capital appreciation or both, is classified as investment property. Investment property is measured initially at its cost, including related transaction costs and where applicable borrowing costs. Subsequent expenditure is capitalised to the asset's carrying amount only when it is probable that future economic benefits associated with the expenditure will flow to the Company and the cost of the item can be measured reliably. All other repairs and maintenance costs are expensed when incurred. When part of an investment property is replaced, the carrying amount of the replaced part is derecognised. Investment properties are depreciated using the straight-line method over their estimated useful

lives. Though the Company measures investment property using cost based measurement, the fair value of investment property is disclosed in the notes.

C. Intangible Assets:

i. Recognition and measurement

Intangible Assets are stated at cost of acquisition less accumulated amortization and accumulated impairment, if any. Amortization is done over their estimated useful life on straight line basis from the date that they are available for intended use, subjected to impairment test.

ii. Amortization

Software, which is not an integral part of the related hardware is classified as an intangible asset and is amortized over the useful life of 3 years.

iii. De-recognition of Intangible Assets

Intangible asset is de-recognised on disposal or when no future economic benefits are expected from its use or disposal. Gains or losses arising from de-recognition of an intangible asset, measured as the difference between the net disposal proceeds and the carrying amount of the asset, are recognised in the Statement of Profit and Loss when the asset is de-recognized.

D. Impairment:

i. Non-financial assets

At each balance sheet date, the Company assesses whether there is any indication that any property, plant and equipment and intangible assets with finite life may be impaired. If any such impairment exists, the recoverable amount of an asset is estimated to determine the extent of impairment, if any. Where it is not possible to estimate the recoverable amount of an individual asset, the Company estimates the recoverable amount of the cash-generating unit to which the asset belongs.

Recoverable amount is the higher of fair value less costs of disposal and value in use. If the recoverable amount of the asset (or cash-generating unit) is estimated to be less than its carrying amount, the carrying amount of the asset (or cash-generating unit) is reduced to its recoverable amount. An impairment loss is recognised in statement of Profit and Loss.

E. Leases:

A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

Company as a lessee

(A) Lease Liability

At the commencement date, the Company measures the lease liability at the present value of the lease payments that are not paid at that date. The lease payments shall be discounted using incremental borrowing rate.

(B) Right-of-use assets

Initially recognised at cost, which comprises the initial amount of the lease liability adjusted for any lease payments made at or prior to the commencement date of the lease plus any initial direct costs less any lease incentives.

Subsequent measurement

(A) Lease Liability

Company measure the lease liability by (a) increasing the carrying amount to reflect interest on the lease liability; (b) reducing the carrying amount to reflect the lease payments made; and (c) remeasuring the carrying amount to reflect any reassessment or lease modifications.

(B) Right-of-use assets

Subsequently measured at cost less accumulated depreciation and impairment losses. Right-of-use assets are depreciated from the commencement date on a straight line basis over the shorter of the lease term and useful life of the underlying asset.

Impairment

Right of use assets are evaluated for recoverability whenever events or changes in circumstances indicate that their carrying amounts may not be recoverable. For the purpose of impairment testing, the recoverable amount (i.e. the higher of the fair value less cost to sell and the value-in-use) is determined on an individual asset basis unless the asset does not generate cash flows that are largely independent of those from other assets. In such cases, the recoverable amount is determined for the Cash Generating Unit (CGU) to which the asset belongs.

Short term Lease

Short term lease is that, at the commencement date, has a lease term of 12 months or less. A lease that contains a purchase option is not a short-term lease. If the Company elected to apply short term lease, the lessee shall recognise the lease payments associated with those leases as an expense on either a straight-line basis over the lease term or another systematic basis. The lessee shall apply another systematic basis if that basis is more representative of the pattern of the lessee's benefit.

As a lessor

Leases for which the Company is a lessor is classified as a finance or operating lease. Whenever the terms of the lease transfer substantially all the risks and rewards of ownership to the lessee, the contract is classified as a finance lease. All other leases are classified as operating leases.

Lease income is recognised in the statement of profit and loss on straight line basis over the lease term.

F. Inventories:

Inventories are measured at the lower of Cost and Net Realizable Value. The cost of inventories is based on the first-in first-out formula, and includes expenditure incurred in acquiring the inventories, production or conversion costs and other costs incurred in bringing them to their present location and condition. In the case of manufactured inventories and work in progress, costs include an appropriate share of fixed production overheads based on normal operating capacity.

Net realizable value is the estimated selling price in the ordinary course of business, less the estimated costs of completion and selling expenses. The Net realisable value of work in progress is determined with reference to the selling prices of related finished products.

Raw materials, components and other supplies held for use in the production of finished products are not written down value below cost except in cases where material prices have declined and it is estimated that the cost of the finished products will exceed their net realisable value.

G. Investments and Other Financial Assets:

i. Classification:

The Company classifies its financial assets in the following measurement categories:

- Those to be measured subsequently at fair value (either through other comprehensive income, or through Statement of Profit and Loss); and
- Those measured at amortized cost.

The classification depends on the Company's business model for managing the financial assets and the contractual terms of the cash flows. For assets measured at fair value, gains and losses will either be recorded in Statement of Profit and Loss or other comprehensive income. For investments in debt instruments, this will depend on the business model in which the investment is held. For investments in equity instruments, this will depend on whether the Company has made an irrevocable election at the time of initial recognition to account for the equity investment at fair value through other comprehensive income.

The Company reclassifies debt or equity investments when and only when its business model for managing those assets changes.

ii. Measurement

At initial recognition, in case of a financial asset not at fair value through profit and loss, the Company measures a financial asset at its fair value plus, transaction costs that are directly attributable to the acquisition of the financial asset. Transaction costs of financial assets carried at fair value through Statement of Profit and Loss are expensed in Statement of Profit and Loss.

- Amortized cost:** Assets that are held for collection of contractual cash flows where those cash flows represent solely payments of principal and interest are measured at amortized cost.
- Fair Value through Other Comprehensive Income (FVOCI):** Assets that are held for collection of contractual cash flows and for selling the financial assets, where the assets cash flows represent solely payments of principal and interest, are measured at FVOCI. Movements in the carrying amount are taken through Other Comprehensive Income (OCI), except for the recognition of impairment gains or losses, interest revenue and foreign exchange gains and losses which are recognized in Statement of Profit and Loss. When the financial asset is derecognized, the cumulative gain or loss previously recognized in OCI is reclassified from equity to profit and loss and recognized in other gains/losses. Interest income from these financial assets is included in other income using the effective interest rate method.

- Fair value through profit and loss:** Assets that do not meet the criteria for amortized cost or FVOCI are measured at fair value through Statement of Profit and Loss. Interest income from these financial assets is included in other income.

Trade Receivables:

Initial recognition and measurement

All financial assets are recognised initially at fair value plus, in the case of financial assets not recorded at fair value through profit or loss, transaction costs that are attributable to the acquisition of the financial asset. However, trade receivables that do not contain a significant financing component are measured at transaction price. Purchases or sales of financial assets that require delivery of assets within a time frame established by regulation or convention in the marketplace (regular way trades) are recognised on the trade date, i.e., the date that the Company commits to purchase or sell the asset.

iii. Equity Instruments

The Company subsequently measures all equity investments at fair value. Where the Company's management has elected to present fair value gains and losses on equity investments in OCI, there is no subsequent reclassification of fair value gains and losses to Statement of Profit and Loss. Dividends from such investments are recognized in Statement of Profit and Loss as other income when the Company's right to receive payment is established.

Changes in the fair value of financial assets at fair value through profit and loss are recognized in other gain/losses in the Statement of Profit and Loss. Impairment losses (and reversal of impairment losses) on equity investments measured at FVOCI are not reported separately from other changes in fair value.

iv. Derecognition

A financial asset is derecognized only when

- The Company has transferred the rights to receive cash flows from the financial asset; or
- Retains the contractual rights to receive the cash flows of the financial asset, but assumes a contractual obligation to pay the cash flows to one or more recipients.

H. Cash and Cash Equivalents:

Cash and cash equivalents in the balance sheet comprise cash at banks and on hand and highly liquid investments with an original maturity of three months or less, which are subject to an insignificant risk of changes in value.

Cash flow statement

Cash flows are reported using the indirect method, whereby profit for the period is adjusted for the effects of transactions of a non-cash nature, any deferrals or accruals of past or future operating cash receipts or payments and item of income or expenses associated with investing or financing cash flows. The cash flows from the operating, investing and financing activities of the Company are segregated.

I. Financial Liabilities:

i. Measurement

All financial liabilities are recognized initially at fair value and in the case of loans, borrowings and payables recognized net of directly attributable transaction costs.

The Company's financial liabilities include trade and other payables, loans and borrowings.

ii. Derecognition

A financial liability is derecognized when the obligation under the liability is discharged or cancelled or expires. Gains and losses are recognized in Statement of Profit and Loss when the liabilities are derecognized as well as through the Effective Interest rate (EIR) amortization process.

J. Foreign Currency Translation:

Items included in the financial statements of the Company are measured using the currency of the primary economic environment in which the entity operates ('the functional currency'). The Indian Rupee (INR) is the functional and presentation currency of the Company.

Foreign currency transactions are recorded on initial recognition in the functional currency, using the exchange rate at the date of the transaction. At each balance sheet date, foreign currency monetary items are reported using the closing exchange rate. Exchange differences that arise on settlement of monetary items or on reporting at each balance sheet date of the Company's monetary items at the closing rate are recognized as income and expenses in the Statement of Profit and Loss, in the period in which they arise.

K. Revenue recognition:

Revenue from contracts with customers is recognised when control of the goods or services are transferred to the customer at an amount that reflects the consideration to which the Company expects to be entitled in exchange for those goods or services. The Company assesses promises in the contract that are separate performance obligations to which a portion of transaction price is allocated.

Revenue from the sale of goods is recognized at the point in time when control of the asset is transferred to the customer, generally on the delivery of the goods.

Revenue towards satisfaction of a performance obligation is measured at the amount of transaction price (net of variable consideration) allocated to that performance obligation. The transaction price of goods sold, and services rendered is net of variable consideration on account of various discounts, schemes, rebates offered by the Company as part of the contract.

The Company considers whether there are other promises in the contract that are separate performance obligations to which a portion of the transaction price needs to be allocated. In determining the transaction price, the Company considers the effects of variable consideration, the existence of significant financing component, non-cash component and consideration payable to the customer like return, allowances, trade discounts, liquidated damages and volume rebates.

Sales are disclosed excluding net of sales returns, service tax, value added tax and Goods and Service Tax (GST).

i. Export Incentives

Export incentives are recognized when the right to receive them as per the terms of the entitlement is established in respect of exports made.

The benefits accrued under the duty drawback scheme, Merchandise Export from India Scheme (MEIS) and RoDTEP as per the Import and export Policy in respect of exports under the said scheme are recognised when there is a reasonable assurance that the benefit will be received and the Company will comply with all attached conditions. The above benefits have been included under the head 'Export Incentives.'

ii. Other Income

i) Other income is comprised primarily of interest income, gain/loss on investments and exchange gain/loss on foreign currency transactions. Interest income is recognized using the effective interest method.

L. Employee benefits:

i. Short-term obligations

Liabilities for wages and salaries, including non-monetary benefits that are expected to be settled wholly within 12 months after the end of the period in which the employees render the related service are recognised in respect of employee's services up to the end of the reporting period and are measured at the amounts expected to be paid when the liabilities are settled. The liabilities are presented as current employee benefit obligations in the balance sheet.

ii. Provident Fund

Contribution towards provident fund for employees is made to the regulatory authorities, where the Company has no further obligations. Such benefits are classified as Defined Contribution Schemes as the Company does not carry any further obligations, apart from the contributions made on a monthly basis.

iii. Gratuity

The Company provides for gratuity, a defined benefit plan (the "Gratuity Plan") covering eligible employees in accordance with the Payment of Gratuity Act, 1972. The Gratuity Plan provides a lump sum payment to vested employees at retirement, death, incapacitation or termination of employment, of an amount based on the respective employee's salary and the tenure of employment. The gratuity plan in Company is funded through annual contributions to Life Insurance Corporation of India (LIC) under its Company's Gratuity Scheme. The liability or asset recognised in the balance sheet in respect of defined benefit gratuity plans is the present value of the defined benefit obligation at the end of the reporting period less the fair value of plan assets. The Company's liability is actuarially determined (using the Projected Unit Credit method) at the end of each year. The present value of the defined benefit obligation is determined by discounting the estimated future cash outflows using interest rates of government bonds. Remeasurement gains and losses arising from experience adjustments and changes in actuarial assumptions are charged or credited to equity in other comprehensive

income in the period in which they arise. They are included in retained earnings in the statement of changes in equity and in the balance sheet.

iv. Compensated Absences

Entitlement of employees accumulating earned leave and eligibility of compensation or encashment of the same is also a defined benefit obligation and is treated as long term in nature in terms of the policies of the Company for the same. The value of obligation towards the same is provided for on the basis of actuarial valuation using projected unit credit method as at the balance sheet date. Actuarial gain/losses are immediately taken to the Statement of Profit and Loss and are not deferred.

M. Borrowing costs:

Borrowing costs that are directly attributable to the acquisition, construction or production of a qualifying asset are capitalised during the period of time that is required to complete and prepare the asset for its intended use or sale. Qualifying assets are assets that necessarily take a substantial period of time to get ready for their intended use or sale.

Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalization.

Other borrowing costs are expensed in the period in which they are incurred.

N. Taxation:

The income tax expense or credit for the period is the tax payable on the current period's taxable income based on the applicable income tax rate adjusted by changes in deferred tax assets and liabilities attributable to temporary differences.

The current income tax charge is calculated on the basis of the tax laws enacted or substantively enacted at the end of the reporting period in India. Management periodically evaluates positions taken in tax returns with respect to situations in which applicable tax regulation is subject to interpretation. It establishes provisions where appropriate on the basis of amounts expected to be paid to the tax authorities.

Deferred income tax assets and liabilities are recognized for all temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the financial statements.

Deferred income tax assets are recognised to the extent that it is probable that taxable profit will be available against which the deductible temporary differences and the carry forward unused tax losses can be utilised.

The carrying amount of deferred income tax assets is reviewed at each reporting date and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred income tax asset to be utilised.

Deferred tax assets and liabilities are measured using substantively enacted tax rates expected to apply to taxable income in the years in which the temporary differences are expected to be received or settled.

O. Provisions and Contingencies:

i. Provisions

Provisions for legal claims, product warranties and make good obligations are recognised when the Company has a present legal or constructive obligation as a result of past events, it is probable that an outflow of resources will be required to settle the obligation and the amount can be reliably estimated. Provisions are not recognised for future operating losses.

Where there are a number of similar obligations, the likelihood that an outflow will be required in settlement is determined by considering the class of obligations as a whole. A provision is recognised even if the likelihood of an outflow with respect to any one item included in the same class of obligations may be small.

Long-term provisions are determined by discounting the expected future cash flows at a pre-tax rate that reflects current market assessments of the time value of money. Short term provisions are carried at their redemption value and are not offset against receivables from reimbursements.

Provisions are measured at the present value of management's best estimate of the expenditure required to settle the present obligation at the end of the reporting period. The discount rate used to determine the present value is a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the liability. The increase in the provision due to the passage of time is recognised as interest expense.

ii. Contingent Liabilities

Contingent liabilities are disclosed when there is a possible obligation arising from past events, the existence of which will be confirmed only by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Company or a present obligation that arises from past events where it is either not probable that an outflow of resources will be required to settle or a reliable estimate of the amount cannot be made.

iii. Contingent Assets

Contingent Assets are not recognised but are disclosed in the notes to the financial statements.

P. Earnings per Share:

i. Basic earnings per share

Basic earnings per share is calculated by dividing:

- the profit attributable to owners of the Company, excluding any costs of servicing equity other than ordinary shares.
- by the weighted average number of equity shares outstanding during the financial year, adjusted for bonus elements in equity shares issued during the year.

ii. Diluted earnings per share

Diluted earnings per share adjusts the figures used in the determination of basic earnings per share to take into account:

- the after income tax effect of interest and other financing costs associated with dilutive potential equity shares, and
- the weighted average number of additional ordinary shares that would have been outstanding assuming the conversion of all dilutive potential equity shares.

Q. Segment reporting:

Operating segments are reported in a manner consistent with the internal reporting to the Chief Operating Decision Maker "CODM" of the Company. The CODM is responsible for allocating resources and assessing performance of the operating segment. The Company has monthly review and forecasting procedure in place and CODM reviews the operations of the Company as a whole.

R. Exceptional items:

Certain occasions, the size, type or incidence of an item of income or expense, pertaining to the ordinary activities of the Company is such that its disclosure improves the understanding of the performance of the Company, such income or expense is classified as an exceptional item and accordingly, disclosed in the notes accompanying to the financial statements.

2.2 RECENT PRONOUNCEMENTS

Ministry of Corporate Affairs ("MCA") notifies new amendments to the existing standards under Companies (Indian Accounting Standards) Rules as issued from time to time. For the year ended March 31, 2026, MCA has notified amendments to Ind AS 21-The Effects of Changes in Foreign Exchange Rates, Ind AS 1-Presentation of Financial Statements, Ind AS 7-Statement of Cash Flows, Ind AS 107-Financial Instruments: Disclosures and Ind AS 12, International Tax Reform – Pillar Two Model Rules. 48. FINANCIAL RISK MANAGEMENT

The Company's Board of Directors has overall responsibility for the establishment and oversight of the Company's risk management framework.

The Company's risk management policies are established to identify and analyse the risks faced by the Company, to set appropriate risk limits and controls and to monitor risks. Risk management policies and systems are reviewed regularly to reflect changes in market conditions and the Company's activities.

(A) Credit risk

Credit risk is the risk of incurring a loss that may arise from a borrower or debtor failing to make required payments. Credit risk arises mainly from outstanding receivables from free market dealers, cash and cash equivalents, employee advances and security deposits. The Company manages and analyses the credit risk for each of its new clients before standard payment and delivery terms and conditions are offered.

(i) Credit risk management

The Company's exposure to credit risk is influenced mainly by the individual characteristics of each customer. The demographics of the customer and including the default risk of the industry, also has an influence on credit risk assessment. Credit risk is managed through credit approvals, establishing credit limits and continuously monitoring the creditworthiness of customers to which the Company grants credit terms in the normal course of business.

The Company considers the probability of default upon initial recognition of asset and whether there has been a significant increase in credit risk on an ongoing basis through each reporting period. To assess whether there is a significant increase in credit risk the Company compares the risk of default occurring on asset as at the reporting date with the risk of default as at the date of initial recognition. It considers reasonable and supportive forwarding-looking information such as:

- Actual or expected significant adverse changes in business;
- Actual or expected significant changes in the operating results of the counterparty;
- Financial or economic conditions that are expected to cause a significant change to the counterparty's ability to meet its obligations;
- Significant increase in credit risk on other financial instruments of the same counterparty;

- v) Significant changes in the value of the collateral supporting the obligation or in the quality of the third-party guarantees or credit enhancements.

Financial assets are written off when there is no reasonable expectations of recovery, such as a debtor failing to engage in a repayment plan with the Company. Where loans or receivables have been written off, the Company continues to engage in enforcement activity to attempt to recover the receivable due. Where recoveries are made, these are recognized as income in the statement of profit and loss.

For trade receivables, the Company applies the simplified approach permitted by Ind AS 109 Financial Instrument, which requires expected lifetime losses to be recognized from initial recognition of the receivables. When determining whether the credit risk of a financial asset has increased significantly since initial recognition and when estimating expected credit Losses (ECL), the Company considers reasonable and relevant information that is available without undue cost or effort. This includes both quantitative and qualitative information and analysis, based on the Company's historical experience and informed credit assessment and including forward looking information.

49. CAPITAL MANAGEMENT

Risk management

For the purpose of the company's capital management, equity includes equity share capital and all other equity reserves attributable to the equity holders of the Company. The Company manages its capital to optimise returns to the shareholders and makes adjustments to it in light of changes in economic conditions or its business requirements. The Company's objectives are to safeguard continuity, maintain a strong credit rating and healthy capital ratios in order to support its business and provide adequate return to shareholders through continuing growth and maximise the shareholders value. The Company funds its operation through internal accruals. The management and Board of Directors monitor the return on capital as well as the level of dividends to shareholders.
