55 ट्रेड लाइसेंस का नवीनीकरण 1, 62,812 की राजस्व वसूली

इंदौर, (नप्र)। नगर पालिक निगम इंदौर के लाइसेंस विभाग द्वारा शहर में बिना वैध ट्रेड लाइसेंस संचालित व्यवसायों के विरुद्ध विशेष जांच एवं प्रवर्तन अभियान निरंतर चलाया जा रहा है। इसी क्रम में आज जवाहर मार्ग क्षेत्र में व्यापक ट्रेड लाइसेंस चेकिंग अभियान संचालित किया गया।

जांच के दौरान जिन प्रतिष्ठानों के ट्रेड लाइसेंस का नवीनीकरण लंबित पाया गया, उन्हें तत्काल नियमानुसार नवीनीकरण कराया गया। इस कार्रवाई में कुल 55 ट्रेड लाइसेंस का नवीनीकरण किया गया तथा 62,812 की राजस्व वसूली की



गई।

हार्डकोर्ट में एसीपी ने दी जानकारी, कोर्ट ने कहा, झुलसे लोगों की इलाज की राशि रिफंड करें

इंदौर, (नप्र)। विजय नगर स्थित अर्बनिका गैस पाइपलाइन में 23 जून को हुए हादसे को लेकर मंगलवार को मध्य प्रदेश हाईकोर्ट की इंदौर बेंच में सुनवाई हुई। सुनवाई में पेश हुए एसीपी पराग सैनी ने कोर्ट को जानकारी दी गई कि इस मामले में बीजेपी पार्षद बालमुकुंद सोनी पर केस दर्ज कर आरोपी बना लिया गया है।

नगर निगम की रिपोर्ट में भी यह उल्लेख किया गया था कि निगम की ओर से बोरिंग नहीं कराई कराई जा रही थी। झुलसे लोगों की ओर से वकीलों ने बताया कि अभी तक उन्हें इलाज की राशि नहीं मिली है। साथ ही अभी भी इलाज जारी है। इस पर कोर्ट ने शासन को कहा कि झुलसे लोगों के इलाज की राशि का पेमेंट रिफंड करवाएं।

शासन की ओर से एडवोकेट ने बताया कि इस मामले में राशि इलाज के बाद जारी होती है, इस पर पीड़ितों की ओर से कहा गया कि अभी तो अस्पताल को उनके इलाज की राशि चाहिए जो हमें खर्च करना पड़ रही है। इस कोर्ट ने शासन को जल्द राशि रिलीज करने के लिए निर्देशित किया।

10 करोड़ के लोन का झांसा देकर 1 करोड़ ठगे

कोर्ट के आदेश पर कारोबारी को वापस मिले रुपए, वीडियो कॉल पर दिखाए थे 10 करोड़

इंदौर, (नप्र)। एक बड़े कारोबारी से 10 करोड़ रुपए का लोन दिलाने का झांसा देकर 1 करोड़ रुपए की ठगी हो गई। अब इस मामले में जिला कोर्ट के आदेश पर पीड़ित को पूरी राशि वापस मिल गई है।

कोर्ट के निर्देश के बाद बैंक ने आरोपियों के खातों में फ्रीज किए गए 1 करोड़ रुपए कारोबारी के खाते में ऑनलाइन ट्रांसफर कर दिए। साइबर टीम के मामले में इतनी बड़ी राशि की वापसी इंदौर जिला कोर्ट में अपने तरह का अहम मामला माना जा रहा है।

दरअसल, कारोबारी को अपने व्यवसाय के लिए 10 करोड़ रुपए के लोन की जरूरत थी। उसने कई बैंकों और वित्तीय संस्थानों में आवेदन किया,

लेकिन सफलता नहीं मिली। इसी दौरान चेन्नई की एक कंपनी के प्रतिनिधियों ने संपर्क कर 10 करोड़ रुपए का लोन दिलाने का दावा किया।

आरोपियों ने जरूरी दस्तावेज मंगवाकर कारोबारी को चेन्नई बुलाया। वहां भरोसा जीतने के लिए 10 करोड़ रुपए का डिमांड ड्राफ्ट (डीडी) दिखाया और लोन मंजूर होने का दावा करते हुए कई दस्तावेजों, चेक और स्टाम्प पेपर पर हस्ताक्षर करवा लिए।

प्रोसेसिंग फीस के नाम पर एंठ लिए 1 करोड़ रुपए- आरोपियों ने अपनी कला, साहित्य और रचनात्मक अभिव्यक्ति के माध्यम से एक स्वर में संदेश दिया कि नशे से दूरी है जरूरी। कार्यक्रम का शुभारंभ पुलिस आयुक्त नगरीय इंदौर संतोष कुमार सिंह द्वारा दीप प्रज्वलन के साथ किया गया। इस अवसर

वीडियो कॉल पर दिखाए 10 करोड़ रुपए कैश, फिर मांगे 20 लाख- पीड़ित के अधिवक्ता रोहित जैन ने बताया कि ठगों ने भरोसा बढ़ाने के लिए एक और चाल चली। वे चेन्नई से इंदौर आए और वीडियो कॉल पर 10 करोड़ रुपए नकद होने का दावा किया। आरोपियों ने कहा कि यदि कारोबारी 20 लाख रुपए और दे दे, तो उसे पूरा लोन नकद दे दिया जाएगा। हालांकि इस बार कारोबारी को संदेह हो गया। उसे लगा कि पहले की तरह यह रकम भी डूब

DISASTER | Thousands remain in relief camps; Army, NDRF step up rescue operations

Assam flood toll rises to 11 as over 3.1L remain affected

GUWAHATI

The toll in Assam floods increased to 11 with one more fatality reported on Tuesday even as over 3.10 lakh people remained affected by the deluge in 11 districts, officials said.

Several major rivers, including the Brahmaputra, Dikhow, Desang and Dhan-siri, were flowing above the danger level in different parts of the state, with some of the water bodies having breached the "extreme flood" level.

Relief and rescue operations were being carried out by multiple agencies, including the Army, NDRF, SDRF and Fire and Emergency Services.

Train services remained affected for the second day as floodwaters inundated tracks in parts of Upper Assam, with the Northeast Frontier Railway (NFR) cancelling, short-terminating or diverting several trains and also announcing special trains for stranded passengers.

**Train services suspended**

Due to severe flooding in and around Simaluguri town in Sivasagar district under the Tinsukia Division of Northeast Frontier Railway, train services between the Simaluguri-Namtiali and Simaluguri-Selenghat sections have been suspended.

Management Authority (ASDMA) statement said that one fatality was reported in Charaideo district, taking the toll in this year's floods to 11.

More than 3,10,800 people remained affected in 758 villages in Biswanath, Charaideo, Dhemaji, Dibrugarh, Golaghat, Jorhat, Kamrup, Karbi Anglong, Nagaon, Sivasagar and Tinsukia districts.

In worst-hit Sivasagar district, the Dikhow and Desang rivers flowed above the "extreme flood level" in Sivsagar town and Nanglamoraghat, respectively, the ASDMA said.

The Dhansiri River was in "severe flood situation" at Numaligarh in Golaghat district,

it added.

Other rivers in spate were the Brahmaputra at Neama-

tightah (Jorhat) and Buridihing at Khowang (Dibrugarh).

Heavy rainfall triggers alert in Rajouri

Heavy rainfall lashed Jammu and Kashmir's Rajouri district from early Tuesday morning, prompting the district administration and Rajouri Police to issue advisories asking residents to remain alert amid apprehensions of a rise in river water levels and the risk of flash floods, landslides and waterlogging. The district administration advised people to avoid unnecessary travel during the ongoing spell of heavy rain and urged them to stay away from rivers, streams and flood-prone areas. Residents were also asked not to attempt crossing flooded roads or bridges and to follow weather updates and instructions issued by the administration.

According to the public advisory, people have been requested to remain indoors unless travel is essential and to cooperate with the administration. In case of any emergency, residents have been asked to immediately contact the local administration or emergency services.

Rajouri Police also issued an urgent advisory, warning that the continuous heavy rainfall could lead to a rapid increase in the water level of rivers in the district.

Char Dham Yatra resumes after weather improves

The Char Dham Yatra, which had been temporarily suspended as a precautionary measure due to incessant rains and landslides, resumed on Tuesday, officials said.

According to the officials, the pilgrimage, which was suspended on Monday, has been smoothly restarted following a necessary review of the travel routes. Garhwal Commissioner Anand Swaroop said that the pilgrimage is being conducted in coordination

with the administrations of all districts associated with the Yatra, the police, the State Disaster Response Force (SDRF), and relevant departments.

He mentioned that the travel routes are being continuously monitored, and special vigilance is being maintained in vulnerable areas. Swaroop also appealed to pilgrims that if the route is temporarily obstructed at any point due to heavy rain, landslides, or other reasons, they should stay at safe locations or 'holding areas' designated by the administration.
