This has reference to the First Call Money Notice dated January 09, 2026, First Reminder Notice for payment of First Call Money dated March 04, 2026, Second Call Notice dated March 21, 2026, and Reminder for First and Second Call Money dated May 04, 2026, Third and Final Call Money Notice dated May 30, 2026 and Reminder for First and Second Call Money dated June 22, 2026 issued by the Company in relation to the partly paid-up equity shares allotted under the Rights Issue.

Shareholders who have already paid the Call Money on the original due date, if any, may kindly ignore this reminder.
