Chennai, July 28: Scientists and officials of the Combat Vehicles Research and Development Establishment (CVRDE) in Avadi paid tribute to former President APJ Abdul Kalam on his 11th death anniversary on Monday.

Kalam, a Bharat Ratna recipient and former President, died on July 27, 2015, while delivering a lecture at the Indian Institute of Management Shillong.

During the observance, officials recalled Kalam's contributions to India's scientific and technological



development and his influence on young people.

Organisation (DRDO), is involved in developing technologies for combat vehicles used by the armed forces.
