CM says UCC to ensure equal rights & justice to all

Bhopal, Jul 23 (UNI) Asserting that the the objective of the Uniform Civil Code (UCC) is to ensure equal rights and equal justice for all citizens, Madhya Pradesh Chief Minister Dr Mohan Yadav today said that the UCC has received widespread support from members of different religious communities and social groups in the state.

He noted that the UCC would safeguard the rights of citizens from all sections of society.

The Madhya Pradesh State Assembly passed the Madhya Pradesh Uniform Civil Code Bill, 2026 by voice vote on July 21 during the five-day Assembly monsoon session, which began on 20 July, but was declared adjourned sine die on July 22, two days before schedule.Addressing an event at Indore today, the CM informed that the state government had reached out to more than 3.5 crore people over nearly two months during consultations on the UCC, and received over 10 lakh suggestions.

He said Madhya Pradesh had joined a select group of four states where the rights of citizens from all sections could be protected under a common legal framework

following the passage of the bill.

Yadav said the proposed UCC covered matters related to marriage, divorce and inheritance.

"Uniform laws will apply to people of all religions, including Hindus, Muslims, Sikhs, and Christians, through the Uniform Civil Code," he said.

He said the initiative is in line with the spirit of the Constitution and is an important step towards strengthening social harmony, equality and justice. The Chief Minister said that the state government remains committed to protecting the interests of all sections of society and ensuring equal opportunities for everyone.Dr Yadav thanked representatives of different religious communities and social organisations for their support. He said their trust and cooperation would further strengthen inclusive development and social harmony in the state.

Later, the CM inaugurated one arm of the newly built double-decker overbridge, built at a cost of Rs 175 crore, at Lav Kush Square on the Indore-Ujjain Road.

Congress refuses discussion without Pradhan's exit, steps up attack on Centre over Exam row

New Delhi, July 23 (UNI) : The Congress on Thursday sharpened its offensive against the Narendra Modi government over the alleged examination paper leaks and the treatment of protesting students, with Congress President and Leader of the Opposition in the Rajya Sabha Mallikarjun Kharge declaring that the party would agree to a discussion in Parliament only after union Education Minister Dharmendra Pradhan resigns, while Congress leader Priyanka Gandhi Vadra accused the government of suppressing democratic dissent and evading responsibility for repeated paper leaks.

Speaking to reporters in the Parliament House complex amid the continuing confrontation between the treasury benches and the Opposition during the Monsoon Session, Priyanka Gandhi questioned the ruling BJP's decision to stage protests outside Parliament, saying it reflected the government's inability to conduct the proceedings of the House.

"Have you ever seen, in the history of our democracy, ruling party MPs themselves staging a protest outside Parliament?

They are unable to run Parliament. They are extremely weak and cowardly," she said.

Expressing solidarity with students protesting against the alleged examination irregularities, Priyanka Gandhi accused the government of using force against young demonstrators instead of addressing their concerns.

"Is this how the youth are treated in a democracy? They are being subjected to repression for raising legitimate demands. They are being lathi-charged and tear gas is being used against them," she said.

She also targeted Prime Minister Narendra Modi, alleging that while he claimed credit for national achievements, he was refusing to accept responsibility for the alleged failures of the examination system.

"The Prime Minister claims credit for every achievement of every Indian, even for India's mission to Mars. Why, then, is he not taking responsibility for the paper leaks? There have been 152 paper leaks, and no one has been punished. Prime Minister Modi must take responsibility for this," she said.

Congress President and Leader of the Opposition in the Rajya Sabha

Continued absence of LoP Tejaswi Yadav, echoes in Bihar Assembly, BJP questions his accountability

Patna, July 23 (UNI) The continued absence of Leader of Opposition (LoP) Tejashwi Yadav from the Bihar Assembly during the ongoing Monsoon Session echoed in the lower house, with the ruling BJP questioning his commitment to legislative responsibilities and demanding that the House be informed about his whereabouts.

Agriculture Minister Vijay Kumar Sinha raised the issue during the debate on the First Supplementary of Income and Expenditure for 2026-27 and expressed concern over the repeated absence of Yadav.

Addressing the Chair, Sinha said the House had the right to know where the LoP was. "The strength of parliamentary democracy lies in a vigilant Opposition. A government can ensure good governance only when the Opposition remains alert and actively participates in the functioning of the House," he said.

Calling Tejashwi Yadav's prolonged absence contrary to the dignity of the legislature, Sinha remarked, "The Leader of the House and the Leader of Opposition are symbols of the prestige of this House.

The Assembly has the right to know where the Leader of Opposition is whether he is safe, whether he is in the country or abroad? The Chair should inform the House."

Mallikarjun Kharge, addressing reporters separately in Parliament, reiterated the Opposition's demand for a discussion under Rule 267 in the Rajya Sabha and accused the government of refusing to permit such a debate.

"We wanted a discussion in the House under Rule 267, but the government was not prepared to allow it," Kharge said.

Escalating the Congress' political offensive, Kharge alleged that the government had insulted not only Congress leaders but also the students protesting over the examination controversy.

"The Modi government has insulted Rahul Gandhi, Priyanka Gandhi, and the students," he said.

Kharge made it clear that the Congress would not participate in a n y discussion on the issue unless the Education Minister stepped down.

Activist Anna Hazare says violence not solution after writing to PM In

Mumbai, Jul 23 (UNI) :Veteran Gandhian activist Anna Hazare today stated that violence should never be the solution to resolve differences, a day after he wrote a letter to Prime Minister Narendra Modi regarding the violence and police action during the Cockroach Janata Party's (CJP) protest at Jantar Mantar in New Delhi.

"Narendra Modi is a prominent and respected leader of the country. He should understand that violence is never the way forward," he told media persons.

"Whatever happened was wrong. I have led 22 hunger strikes in my lifetime, and there was never any violent incident. Central government representatives should visit the protesters at Jantar Mantar. There is nothing wrong in listening to the protestors," Hazare said.

In his letter to PM Modi on Wednesday, the 89-year-old Gandhian activist stated that reports of violence and police action were "painful" and that violence, damage to public property as well as unnecessary use of force had no place in a democracy.

Hazare stated in his letter to the PM that the concerns of young people about question paper leaks, delays in recruitment processes, unemployment and other issues should not be viewed merely as law and order problems but as a reflection of wider social distress.

He also stated that resignation of a union cabinet minister would not weaken the government but send a strong message to other ministers about accountability, due to which their performance will improve.

The Gandhian activist's letter referred to the CJP's 'Chalo Sansad' march, to protest NEET examination irregularities and demand the resignation of union Education Minister Dharmendra Pradhan, but the protest witnessed violence after the police used tear gas and lathi charge to disperse protestors.

Hazare further stated that irregularities in the NEET examination system had caused anxiety among students and parents.

He maintained that accountability for irregularities and failures should not be limited to lower-level officials and that senior authorities must also be held responsible.

Hazare's letter to the Prime Minister was written after opposition parties attacked the central government and took up the demands made by CJP protestors to make Dharmendra Pradhan resign.

He stated that in a democracy, dialogue is always a better path than confrontation, even as he urged the central government not to view the voice of the people as the opposition's voice.

He asserted that differences are natural in a democracy, but they should be resolved through dialogue, sensitivity and mutual respect.

The Gandhian activist pointed out that whenever irregularities or scams came to light, responsibility was often fixed only on lower-level officials while the government claimed credit for positive outcomes, emphasising that the ultimate responsibility rested with senior officials.

Hazare questioned why no senior government representative or secretary-level official had engaged with the agitators despite the protest continuing for several days.

SP delegation asks DM Rampur not to demolish Jauhar Ali University

Rampur, Jul 23 (UNI) A Samajwadi Party delegation, led by Leader of the Opposition in the Uttar Pradesh Assembly Mata Prasad Pandey, today submitted a memorandum to District Magistrate Ajay Kumar Dwivedi, demanding the revocation of the order to demolish Azam Khan's Maulana Jauhar Ali University.Pandey, while talking to media, said that efforts are underway for Azam Khan's release from jail."Jauhar University was in the Gram Panchayat at the time of its construction and, it was not mandatory to have the map approved by the Gram Panchayat.If this should happen, many buildings in Rampur would be demolished."We have come to get the order to demolish Jauhar University rescinded. We have spoken to the District Magistrate, submited a memorandum to him, and talked to the students who are protesting. We will bring their concerns before the Governor. We have come to save the university. The party's future strategy is to have Azam Khan released from jail and form the government," he said and claimed that the SP will form the government with a landslide victory.

He maintained that the Jauhar University is a major educational centre and the district administration should withdraw its order.

"The demolition order is based solely on political vendetta. The university building will be saved. We, along with 45 MLAs, have submitted a memorandum to the District Magistrate. Our National President formed a committee of 45 MLAs and district presidents, which submitted a memorandum to the District Magistrate today, demanding the withdrawal of the demolition proceedings," Pandey said.
