Sub: Consolidated Scrutinizer's Report on remote e-voting and e-voting at the AGM conducted pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 as amended by Companies (Management and Administration) Amendment Rules, 2015 for the 46th Annual General Meeting of SANCO TRANS LIMITED held on Wednesday, July 29, 2026 at 10:00 Hrs (IST) through Video Conferencing ('VC') / Other Audio Visual Means ('OAVM')

We, M/s. A K JAIN & ASSOCIATES, Practising Company Secretaries, represented by Mr. BALU SRIDHAR, Partner, had been appointed as the Scrutinizer by the Board of Directors of M/s. Sanco Trans Limited pursuant to Section 108 of the Companies Act, 2013 ("the Act") read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended, to conduct the remote e-voting process in respect of the below mentioned resolutions proposed at the 46th Annual General Meeting ("AGM") of Sanco Trans Limited on Wednesday, July 29, 2026 at 10.00 Hrs (IST) through VC / OAVM. We were also appointed as Scrutinizer to scrutinize the e-voting conducted during the AGM.

The notice dated May 28, 2026, as confirmed by the Company was sent to the Shareholders in respect of the below mentioned resolutions passed at the AGM of the Company through electronic mode to those Members as on the cut-off date (i.e.) Wednesday, July 22, 2026 whose e-mail addresses are registered with the Company/ Depositories, in compliance with General Circular No.03/2025 dated September 22, 2025 read with Previous circulars issued by Ministry of Corporate Affair (MCA) and in accordance with the requirements laid down in Para 3 and Para 4 of the General Circular No. 20/2020 dated 05.05.2020.

The Company had availed the e-voting facility offered by Central Depository Services (India) Limited (CDSL) for conducting remote e-voting and voting at the AGM by the Shareholders of the Company. The period for remote e-voting remained open from Sunday, July 26, 2026 (09:00 Hrs (IST)) Tuesday, July 28, 2026 (17:00 Hrs (IST)) as mentioned in the Notice convening AGM.



The Company had provided e-voting facility to the shareholders who attended the AGM through VC / OAVM and who had not cast their vote in remote e-voting.

The shareholders of the Company holding shares as on the "cut-off" date of Wednesday, July 22, 2026 were entitled to vote on the resolutions as contained in the Notice of the 46th AGM.

As prescribed in Applicable Circulars and in clause (v) of sub rule 4 of the Rule 20 of the Companies (Management and Administration) Rules, 2014, the Company released an advertisement, which was published more than 21 days before the date of the AGM in English in 'Trinity Mirror' and in Tamil in 'Makkal Kural' both dated July 2, 2026. The notice published in the newspaper carried the required information as specified in Sub Rule 4(v)(a) to (h) of the said Rule 20.

In addition to sending notice of the AGM to the shareholders through electronic mode, the Company has also made available the full Annual report on the website of the Company viz., www.sancotrans.com besides notice of the AGM made available in the website of CDSL and BSE.

After the closure of voting at the AGM, the report on e-voting done at the AGM and the votes cast under remote e-voting facility prior to AGM were unblocked by us at **11:03 A.M. (IST)** on July 29, 2026 in the presence of Ms. Sandhya and Mr. Akshar, who are not in the employment of Company.

Based on the data downloaded from the official website of CDSL, we submit the consolidated report as under on the result of the remote e-voting prior to AGM and E-voting at the AGM in respect of said resolutions;
