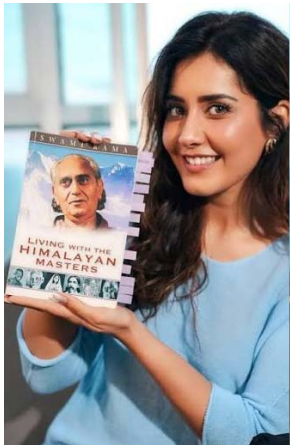

"Main Vaapas Aunga achieves this today and my first thought is of gratitude towards the audience - the good people that watch cinema, who invested emotionally in the film and con-

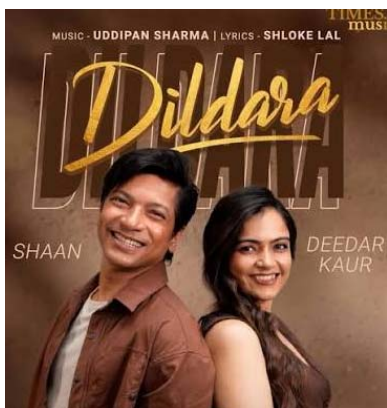
vinced others to watch it, who created the extraordinary word of mouth - for no reason except that they liked the film. May the tribe increase!" Imtiaz wrote.
