From Hitler, Stalin and Hiroshima to now PoK, NYT's 'Pakistani Kashmir' gaffe is no aberration



When The New York Times, reporting on Islamabad's violent crackdown on protests in Pakistan-occupied Kashmir (PoK), mischievously referred to the occupied territory as "Pakistani Kashmir", the Indian Embassy in Washington reacted sharply, calling the description "misleading and incorrect". While the outrage was justified, it should not have surprised anyone. If anything, the episode merely reaffirmed a pattern that has defined the newspaper's engagement with the subcontinent for years. This is, after all, the same newspaper that advertised for the job of a South Asia Business Correspondent in New Delhi while putting its journalistic neutrality on hold. The candidate, it said, should be critical of Prime Minister Narendra Modi and his "muscular nationalism". The implication was unmistakable. The newspaper appeared to regard opposition to the democratically elected Prime Minister of the world's largest democracy as a desirable professional qualification. Curiously, the NYT has never had any such preconditions for postings in Hong Kong or in mainland China. It never asked only those in favour of pro-democratic protests to apply in Hong Kong, or those opposed to Xi Jinping to try for a posting in Beijing. The NYT, it seems, operates in an Orwellian world where war is peace, and democracy is dictatorship. The newspaper has rarely missed an opportunity to frame Bharat through the prism of majoritarianism, democratic decline and Hindu nationalism. Prime Minister Modi is almost invariably introduced with the added descriptors such as "Hindu nationalist" or "Hindu supremacist", reinforcing a particular political narrative. China's authoritarian leadership seldom receives the same treatment. Even Pakistan's military establishment is rarely subjected to comparable moral scrutiny. It's only natural that the NYT's distaste for PM Modi extends to Bharat. The most infamous example in recent years was its caricature of the country's Mars Orbiter Mission, which stunned the world in 2014. The newspaper chose not to celebrate this extraordinary scientific achievement by a developing nation. Instead, it published an infamous cartoon showing a farmer with a cow knocking on the door of an "Elite Space Club". The backlash was so overwhelming that the paper was forced to apologise. To understand why such controversies continue to recur, one need only read Ashley Rindsberg's The Gray Lady Winked. The book presents a sweeping critique of the NYT's historical record, arguing that the newspaper has repeatedly failed at some of history's most defining moments. Rindsberg writes: "The paper (NYT) that, for over four years, feverishly likened Donald Trump to Adolf Hitler was unabashedly pro-Hitler in the Thirties, serving as a sturdy fount of Dr Goebbels's propaganda ("reporting", just as his newspapers did, that Poland invaded Germany on 1 September 1939). The paper that, for 20 years, has made Vladimir Putin out to be a second Stalin was unabashedly pro-Stalin in its coverage of the famine in Ukraine (there wasn't one, according to the Times) and the show trials

(legitimate, according to the Times). And the paper that persistently envisions an imaginary Holocaust in Syria blacked out the real one at the time, having carefully downplayed the Nazis' persecution of the Jews from 1933." According to Rindsberg, the NYT relied heavily on Nazi propaganda during the early years of the Second World War; so much so that at one stage it turned WW-II history upside down when it accused Poland of starting the war by invading Germany! The author also notes that the newspaper initially portrayed Hitler in 1924 as a fading political figure who was "no longer to be feared" and predicted that he would retire quietly to Austria. History, of course, unfolded very differently — and violently. The book is equally critical of the newspaper's Holocaust coverage. Rindsberg argues

All these employees were given salaries of lakhs of rupees. ABVP has alleged that Pawan Pandit has been directly appointed as the director despite not being an employee of the university. Pawan Pandit has been appointed as the Ph.D student of former Vice Chancellor Neerja Gupta by abusing his power. Chandrashekhar Jha and Dinesh Kumar who were in ONCG with Neerja Gupta's husband Arun Kumar. They have been appointed by Neerja Gupta after their retirement. Appointment at a salary of 5 lakhs against UGC rules Without the approval of the government, people identified as UGC rules have been given jobs at a salary of 5 lakhs per month. Some people from Uttar Pradesh have also been appointed in the IKS department. Due to the unconstitutional appointment made by Neerja Gupta, the university has had to bear a financial burden of 10.93 crores in the last 3 years.
