which it is to be disclosed, or that it contains any material misstatement.

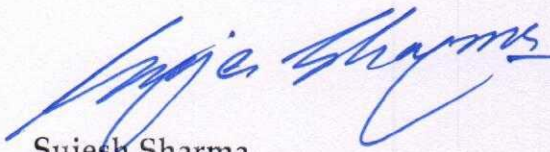

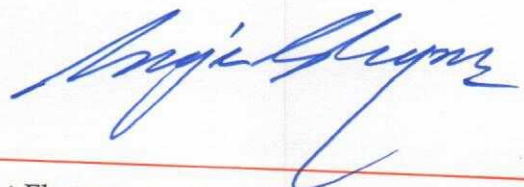

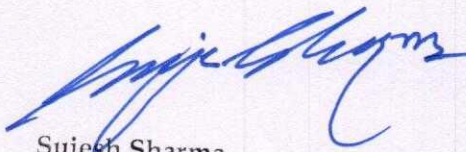
