 - b) Plates, cups, glasses, cutlery such as forks, spoons, knives, straw, trays, wrapping or packing films around sweet boxes, invitation cards, and cigarette packets, plastic or PVC banners less than 100 micron, stirrers.

આ સૂચનાનો અમલ તાત્કાલિક અસરથી કરવાનો રહેશે મ્યુનિસિપલ કોર્પોરેશનની ટીમ દ્વારા આકસ્મિક ચકાસણી કરવામાં આવશે અને ઉપરોક્ત નિયમોનું પાલન ન કરનાર કંપનીઓ - એકમો સામે ગુજરાત પ્રોવિન્સિયલ મ્યુનિસિપલ કોર્પોરેશન્સ (GPMC) એક્ટ-૧૯૪૮ તથા પબ્લિક હેલ્થ બાયલોજ-૨૦૧૨ તેમજ પ્લાસ્ટીક વેસ્ટ મેનેજમેન્ટ રૂલ્સ-૨૦૧૬ અને વખતો વખત થયેલ સુધારાઓ હેઠળ નિયમાનુસાર દંડ-વેપ કાર્યવાહી કરવામાં આવશે. જેમાં માલ-સામાન જામ કરવા તથા એકમને સીલ કરવા સુધીની કાર્યવાહીનો પણ સમાવેશ થઈ શકે છે જેની તમામ સંબંધિતોએ નોંધ લેવા જણાવવામાં આવે છે.
