The Minister made the remarks during his visit to CII FoodPro 2026, the 16th edition of India’s flagship exhibition on food processing, food technologies, packaging, cold chain, food safety and allied industries, at the Chennai Trade Centre. He toured the exhibition stalls, interacted with exhibitors and launched the exhibition catalogue. Alandur MLA Harish was also present.

Venkataramanan said agricultural produce such as drumstick leaves, vegetables and other nutritious products could be processed into powders, soups, tablets and other convenient forms while retaining their nutritional benefits. There has been a revision in the terms of the Non-Convertible Debentures which states an agreed Moratorium for the Coupon payments on from 1st April 2026 till 31st August 2026 which shall be compensated by ramped-up coupon amounts subsequently monthly and final redemption date has been revised to 30th September 2027. Also, Entire Principal amount along-with Coupon and Redemption Premium to meet agreed Default/Penal Interest including other costs, charges, expenses, etc. as per the debenture trust deed are proposed to be paid at the Final Redemption Date.

The arrangement is expected to ensure a stable supply of coal in the upcoming years at a comparatively lower cost than the imported coal procured by the Company in earlier years.
6. The Power Plant was majority under shutdown for the quarter ended 30th June, 2026 except for 4 days of startup power requirement.
