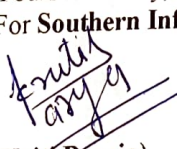

31 मार्च, 2026 तक समूह की स्थिति के अनुसार माल-सूची में 25,880.96 लाख रुपये की माल-सूची शामिल है, जो महाराष्ट्र के नासिक स्थित एक सहायक कंपनी के कारखाने में रखी हुई है। उन परिसर में 21 मई, 2025 को लगी आग के परिणामस्वरूप समेकित वित्तीय परिणामों के नोट 4 का संदर्भ ले। वर्ष के दौरान प्रबंधन ने संबंध के साथ मिलकर माल-सूची का भौतिक सत्यापन किया था तथा आग से क्षतिग्रस्त माल-सूची का भौतिक सत्यापन किया और तदनुसार ऐसी माल-सूची को लेखा बहियों में हट्टे खाते में डाल दिया। हालांकि, आग लगने के कारण कारखाने के परिसर के कुछ क्षेत्र प्रभावित हुए थे और पुनर्निर्माण का कार्य प्रगति पर था, जिसके कारण भंडारण स्थान की कमी हो गई। फलतः उपयोग योग्य अपशिष्ट की कुछ ऐसी माल-सूची, जो आग से प्रभावित नहीं हुई थी, भिन्न अवस्था में रखी गई थी। उपरोक्त परिस्थितियों के कारण, वर्ष के अंत में हम माल-सूची का भौतिक सत्यापन करने तथा उसके सत्यापन के समय उपस्थित रहने में सक्षम नहीं थे। वर्ष के अंत के पश्चात, प्रबंधन द्वारा नियुक्त एक तृतीय पक्ष ने माल-सूची का भौतिक सत्यापन किया था, तथापि यह सत्यापन सभी मदों के लिए नहीं किया गया था और कुछ मामलों में मात्राओं का निर्धारण अनुमान पद्धति से किया गया था। हमने वैकल्पिक क्रियारूप अपनाई थी, जिनमें माल-सूची के बाद की आवाजही का सत्यापन, मात्रात्मक अभिलेखों तथा अन्य संबंधित दस्तावेजों की जांच की गई थी। इन प्रक्रियाओं से हमें ऐसी माल-सूची के अस्तित्व के संबंध में सक्षम प्रभाव हुए। हालांकि, भूकिक हम भौतिक सत्यापन करने में सक्षम नहीं थे, इसलिए मात्राओं में कोई अचिन्ता या कमी, यदि हो, तो संभव है, इसका निर्धारण केवल तभी किया जा सकता है जब आगामी अवधियों में भौतिक सत्यापन किया जाए और हम उस सत्यापन के समय उपस्थित रहें। अतः हम यह निष्कर्षित करने में असमर्थ रहे कि 31 मार्च, 2026 की स्थिति के अनुसार माल-सूची के वतन मूल्य में कोई समाकलन आवश्यक था या नहीं तथा इसका समूह के वर्ष के लाभ, अन्य द्रविकी और समेकित वित्तीय परिणामों में संबंधित प्रकटीकरण पर कोई परिणामी प्रभाव, यदि कोई हो, पड़ा है या नहीं।
