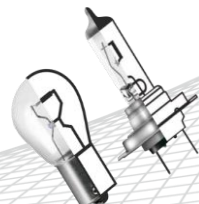

Tata Sons Chairman N Chandrasekaran resigns, to complete term till February

Sons did not immediately respond to a Reuters request for comment. Chandrasekaran could not be reached for comment. Chandrasekaran joined the Tata group in 1987, became TCS' CEO in 2009 before taking over as Tata Sons chair in 2017. Over the past year, the Tata conglomerate has had to grapple with regulatory scrutiny of Air India following a fatal crash, pricing pressure at TCS and a cyberattack at Jaguar Land Rover that disrupted production.
