STALEMATE AT SEA | Contradictory statements cast doubt on diplomatic solution as oil prices rebound after missile attack

US-Iran talks in limbo as ship struck in Hormuz

DUBAI/WASHINGTON

Doubts over a diplomatic resolution to the US-Iran war intensified on Tuesday following a fresh missile strike on a commercial vessel near the Strait of Hormuz, driving oil prices up by nearly 3 percent.

A dry bulk vessel was struck by an unidentified projectile off the coast of Oman, according to maritime security agency UKMTO. The crew was forced to abandon ship, and one seafarer remains missing. The attack reversed a 7 percent drop in Brent crude futures from the previous day, which had been driven by brief optimism over diplomatic progress.

The incident underscored a sharp contradiction between claims made by Washington and Tehran. US President Donald Trump stated on Monday that discussions were under way at the request of regional nations, warning Tehran that it faced a "last chance" to reach an agreement. His comments followed

a decision over the weekend to cancel planned military strikes on Iran.

However, Iranian leadership publicly rejected claims of direct negotiations. Iranian President Masoud Pezeshkian affirmed that Tehran defends its borders but does not seek to widen the war.

Iranian officials clarified that their only active discussions were held with Oman regarding shipping management in the Strait of Hormuz, where traffic remains down to a fraction of peacetime levels due to Ira-

nian restrictions and a US naval blockade.

Analysts from ING and the Washington Institute noted that Iran appears to be leveraging regional energy routes and trade corridors to exert economic pressure on Washington and its allies.

The dispute over Hormuz remains the core point of contention, with Washington demanding the full reopening of the strategic waterway under a previous memorandum, while Tehran maintains it retains legal authority over transit through the strait.

Volcano erupts in Guatemala, two villages evacuated

Guatemala City: Authorities in Guatemala have ordered evacuations in some southern communities around the Fuego volcano, which is erupting. Claudinne Ogaldes, executive secretary of the Guatemalan disaster managing agency, CONRED, confirmed on Monday evening to The Associated Press that the eruption started on Monday morning and increased during the day, which led to evacuation orders for two villages around the mountain.

Migrant children still stranded in Ceuta

The teenage girl made it through the waves to Spanish territory. Her little brother did not, drowning in the Mediterranean, while their mother disappeared in the chaos when tens of thousands of people surged through the breakwater, trying to leave Morocco behind.

The tragic story of a 17-year-old from Tangier is representative of the plight of many of the more than 800 minors who four days after the collective push by migrants into Ceuta face a scary present and an uncertain future.

She told an Associated Press photojournalist how she and her family joined the massive crowd that tried to swim around a border fence to reach the Spanish terri-

tory on Thursday. Like many, she said they did so seeking better opportunities. The AP is withholding her identity because she is a minor in a vulnerable situation.

She described how she saw Spanish police pull the body of her eight-year-old brother from the water.

She made it to the shore but became separated from her mother, and has spent the last four days on her own. She said some locals gave her food and some clothing, with one woman taking her into her home so she could bathe. She then went to a centre for youths run by the government for some help, but found it was full.

"I saw people stepping on the dead," she said through a translator since she does not speak Spanish. "Now, we are children begging on the street." She is one of some

Sanchez's government has fended off the attacks as politically motivated, saying most of the migrants were pushed back from Ceuta within hours in "close coordination with the Moroccan authorities."

Japan eyes drones to counter China

Japan needs to adapt to the new methods of warfare like drones and artificial intelligence used in Ukraine and the Middle East and strengthen its defence industry, the government said Tuesday.

Japan has bolstered its military capability and spending in recent years and has started developing long-range cruise missiles as a deterrence to China's military activity.

The 598-page defence paper

adopted by the Cabinet on Tuesday reiterated that China is Japan's biggest strategic challenge. Japan is alarmed by the growing presence and frequency of Chinese warships in the Pacific Ocean.

Inspired by the use of drones by Ukraine, Japan considers it is essential to adapt to "new ways of warfare," the paper said. With many countries racing to develop combat drones, Japan's government prioritizes development of its own for a coastal defence, in combination with long-range missiles.

SpaceX faces investor scrutiny

Investors in Elon Musk's space company get a chance to question him Tuesday after SpaceX issues its first quarterly earnings since going public.

SpaceX shares are down by half from their June peak as investors worry Musk may have oversold them on its future prospects. They're also bracing for volatile trading as some company insiders get the opportunity to sell shares after the expiration of what's known as a lockup provision later in the week. Part visionary engineer, part stock salesman, Musk is likely to be asked about when he expects to finish testing SpaceX's giant Starship rockets that NASA hopes to use to put men on the moon again, his plans for its satellite network and the prospects of putting football-field sized datacenters in orbit. SpaceX is losing money fast, with net losses for its first half this year expected to exceed more than the \$5 billion in losses for all of last year.

Migrant boat catches fire in English Channel, 157 rescued

French and British teams rescued 157 migrants who were trying to cross the English Channel after the engine of their boat caught fire, French maritime authorities said.

On Tuesday morning, while the boat was still in France's search-and-rescue zone near British waters, its engine caught fire and it rapidly began to break apart, the maritime prefecture for the English Channel and the North Sea said in a statement. French authorities

deployed two rescue ships, a Navy helicopter and medical personnel. Britain's Royal National Lifeboat Institution and Border Force also responded. The rescue operation brought 157 people to safety — 103 rescued by French vessels and 54 by British vessels.
