("OMPL") was earlier associated with our client Shrinshri Medleys Ltd and its subsidiary company (owning 55% equity in OMPL but having minority directors in OMPL) under a Memorandum of Understanding for manufacturing/distribution of the products manufactured exclusively by Shrinshri Medleys Ltd using the trade mark "Osteocare" which is owned by Dipal Modi which is clearly envisaged in MOU. My clients vide Termination Notice dated 15.03.2026, the said MOU came to be terminated as well as my client Shri Dipal Modi individually withdrawn the rights/authorizations granted to OMPL to use the trademark "OSTEOCARE" or any deceptively similar mark.
