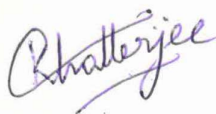

GCC camp helps children return to school

Chennai, Aug. 5: The Greater Chennai Corporation (GCC) organised a special camp at Chennai Middle School in Ezhil Nagar, Sholinganallur, to help school dropouts and students obtain essential documents required for school admission and government welfare schemes.

The camp received 409 applications for services including Aadhaar cards, birth certificates, community and income certificates, ration cards and educational assistance. Officials said the applications would be processed by the respective departments.

The initiative aimed to remove documentation barriers that prevent children from enrolling or continuing in school. Parents were also guided on applying for scholarships and welfare schemes.

Special arrangements were made for orphaned children to apply for financial assistance under the Anbu Karangal scheme, which provides a monthly educational aid of Rs 2,000 until Class XII through the District Child Protection Unit.

Students and parents from schools in Kannagi Nagar and Ezhil Nagar benefited from the camp, where



multiple government departments offered services under one roof. The programme is part of the civic body's efforts to reduce school dropouts and improve access to education.

Collector reviews Ranipet leather effluent treatment plant

Ranipet, Aug. 5: Ranipet Collector N. Priya Ravichandran on Wednesday inspected the Common Effluent Treatment Plant (CETP) at the SIDCO Industrial Estate in Karai village to review its operations and ensure compliance with environmental norms for treating wastewater generated by leather processing units.

The CETP, operated by the Ranipet SIDCO Finished Leather Effluent Treatment Company Ltd., treats industrial effluents from leather tanneries located in the industrial estate before their discharge.

During the inspection, the Collector reviewed the functioning of key treatment facilities, including the reverse osmosis system, multiple-effect evaporator and agitated thin-film dryer, besides examining other stages of the treatment process.

She also assessed the plant's wastewater treatment procedures and the measures adopted to safeguard the environment and comply with pollution control regulations. District Environmental Engineer P. Ananda Narayanan and Assistant Environmental Engineer Vijayakumar of the Tamil Nadu Pollution Control Board, along with SIDCO Project Officer Kalaiselvi, accompanied the Collector during the inspection.
