পাথর ব্যবসার স্বচ্ছতায় অনলাইন ডিসিআর বাজেয়াপ্ত পাথর ও বালি নিলামের ডাক বীরভূম জেলা প্রশাসনের মৃণালজিৎ গোস্বামী

বীরভূম: রাজ্যে সরকার পরিবর্তনের পর বীরভূমে বালি ও পাথর ব্যবসায় স্বচ্ছতা আনতে একাধিক পদক্ষেপ শুরু করেছে জেলা প্রশাসন। দীর্ঘদিন ধরে রাজস্ব ফাকি, নকল ডিসিআর এবং অবৈধ পাথর-বালি মজুদের অভিযোগে আলোচিত টুলু মণ্ডল-কাণ্ডের তদন্ত চলাকালই প্রশাসন নতুন উদ্যোগ হিসেবে অনলাইন ডিসিআর ব্যবস্থা চালু করার সিদ্ধান্ত নিয়েছে। একই সঙ্গে বাজেয়াপ্ত বিপুল পরিমাণ পাথর ও বালির নিলামের উদ্যোগ নেওয়া হয়েছে। প্রশাসন সূত্রে জানা গিয়েছে, মহম্মদবাজার রুকের একটি এলাকায়, যা অভিজ্ঞ টুলু মণ্ডলের পার্শ্বিক এলাকা হিসেবে চিহ্নিত, সেখান থেকে প্রায় ১৬ লক্ষ ঘনফুট পাথর বাজেয়াপ্ত করা হয়েছে। শুক্রবার সেই পাথরের নিলামের বিজ্ঞপ্তি জারি করা হয়েছে। আগামী ১৮ সেপ্টেম্বর নিলাম অনুষ্ঠিত হওয়ার কথা রয়েছে। শুধু পাথর নয়, বালি মজুতের বিরুদ্ধেও কড়া পদক্ষেপ নিয়েছে জেলা প্রশাসন। এর আগে মহম্মদবাজার ভূমি ও

ভূমি সংস্কার দপ্তর টুলু মণ্ডল-সহ একাধিক বালি ব্যবসায়ীর ১০টি বালির স্তম্ভ বাজেয়াপ্ত করে। এবার টুলু মণ্ডলের কুবিলপুর ও দেউড়ায় বাজেয়াপ্ত বালির পাশাপাশি খয়রাশোল, দুবরাজপুর, সিউড়ি ও মহম্মদবাজারে বাজেয়াপ্ত বালির স্তম্ভও নিলামের সিদ্ধান্ত নিয়েছে জেলা ভূমি ও ভূমি সংস্কার দপ্তর। এদিকে পাথর পরিবহন ও সরকারি রাজস্ব আদায়ে স্বচ্ছতা আনতে শুক্রবার মহম্মদবাজার থানার রায়পুরে পরীক্ষামূলকভাবে অনলাইন ডিসিআর ব্যবস্থা চালু করা হয়েছে। এর আনুষ্ঠানিক উদ্বোধন করেন সহিষ্কারিা বিধায়ক কৃষ্ণকান্ত সাহা। প্রশাসনের দাবি, আগামী সপ্তাহের মধ্যেই জেলার ১০টি চেকিং গেটে এই অনলাইন ব্যবস্থা চালু হবে। এর ফলে পরিবহন সংক্রান্ত রাজস্ব সরাসরি সরকারি কোষাগারে জমা পড়বে এবং জাল ডিসিআরের মাধ্যমে রাজস্ব ফাকির সুযোগ অনেকটাই কমে যাবে। এর আগে সিউড়ির বিধায়ক তথ্য রাজ্যের উচ্চশিক্ষামন্ত্রী জগন্নাথ চট্টোপাধ্যায় জানিয়েছিলেন, বালি ও পাথর মাফিয়াদের বিরুদ্ধে সরকার ‘জিরো

মহম্মদবাজারে টুলু মণ্ডলের আত্মীয় মিনার মণ্ডলের বাড়িতে তল্লাশি চালিয়ে প্রায় ২৮.৫ লক্ষ টাকা নগদ এবং প্রায় ১৫ কেজি সোনা উদ্ধার করেছে বলে পুলিশের দাবি। এই ঘটনায় মিনার মণ্ডলকে গ্রেপ্তার করা হয়েছে। শুক্রবার তাঁকে ফের আদালতে তোলা হলে বিচারক ১৪ দিনের জেল হেপাজতের নির্দেশ দেন। একদিকে বাজেয়াপ্ত পাথর ও বালির নিলাম, অন্যদিকে অনলাইন ডিসিআর ব্যবস্থা চালু এই দুই পদক্ষেপের মাধ্যমে বীরভূমের বালি ও পাথর ব্যবসায় স্বচ্ছতা ফিরিয়ে আনার পাশাপাশি সরকারি রাজস্ব বৃদ্ধির লক্ষ্যে জেলা প্রশাসন যে কঠোর অবস্থান নিয়েছে, তা স্পষ্ট বলেই প্রশাসনিক মহলের অভিমত।

দুবরাজপুরের বিডিওর বিরুদ্ধে যৌন হেনস্থার অভিযোগ

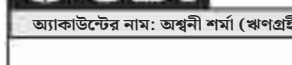
নিজস্ব প্রতিবেদন, **দুবরাজপুর:** দুবরাজপুরের বিডিও জয়সূর্য চক্রবর্তীর বিরুদ্ধে এক মহিলা কর্মীকে যৌন হেনস্থার অভিযোগ থিরে চাঞ্চল্য ছড়িয়েছে এলাকার অভিযোগকারী ওই মহিলা, যিনি ক্যাপারে আক্রান্ত এবং দুবরাজপুর রুকের এক কর্মী, শুক্রবার দুবরাজপুর থানায় বিডিওর বিরুদ্ধে লিখিত অভিযোগ দায়ে র করেছেন। অভিযোগকারীর দাবি, বিভিন্ন অভ্যুহাতে তাঁকে ডেকে নানা থলোভন দেখানো হয় এবং আকারে-ইঙ্গিত কুশান্ত দেওয়া হয়। এমনকি বাংলা কিংবা লজে যাওয়ার প্রস্তাবও দেওয়া হয়েছে বলে তিনি অভিযোগ করেন। প্রথমদিকে ভয় ও মানসিক চাপে বিষয়টি প্রকাশ না করলেও পরে তিনি প্রতিবাদ করেন এবং শেষ পর্যন্ত আইনের দ্বারস্থ হন। মহিলা আরও অভিযোগ করেন, ঘটনার পর বিডিওর স্ত্রীও তাঁর ওপর বিভিন্নভাবে চাপ সৃষ্টি

করার চেষ্টা করেন। ঘটনার খবর পেয়ে অভিযোগকারীর পাশে দাঁড়ান এলাকার বিধায়ক অনূপ সাহা। তিনি বলেন, ‘আইন আইনের পথেই চলবে। রাজ্যে আইনের শাসন প্রতিষ্ঠিত হবে। অভিযোগের নিরাপেক্ষ তদন্ত হওয়া উচিত এবং দোষী প্রমাণিত হলে আইন অনুযায়ী ব্যবস্থা নেওয়া হবে।’ এদিকে, এই প্রতিবেদন লেখা পর্যন্ত বিডিও জয়সূর্য চক্রবর্তীর পক্ষ থেকে কোনও প্রতিক্রিয়া পাওয়া যায়নি।

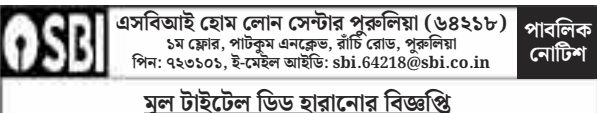
