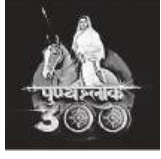

'सेसेक्स-३०'मधील देशातील ११ प्रमुख कंपन्यांकडून केली जाणारी नोकरभरती २०२३-२४च्या तुलनेत २०२५-२६ या आर्थिक वर्षात २७ टक्क्यांनी घसरली आहे, असे या वृत्तात नमूद करण्यात आले आहे. "आम्ही जे सांगत होतो ते खरे ठरत असल्याचे सिद्ध होत आहे, मोदी सरकारने देशाच्या अर्थव्यवस्थेचे मोठे नुकसान केले आहे आणि त्याचा सर्वांत गंभीर परिणाम तरुणांवर होत आहे," असे रमेश यांनी लिहिले.
