2. The figures for the Quarter ended 31<sup>st</sup> March 2026 are the balancing figures between the audited figures in respect of the full financial year and the published year to date figures upto the end of third quarter of the respective financial year, which was subjected to Limited Review.
3. The Government of India has consolidated multiple existing labour legislations into a unified framework comprising of four Labour Codes, collectively referred to as the 'New Labour Codes' and notified with effect from 21<sup>st</sup> November 2025. Based on the analysis of the information available so far and actuarial valuation, the Company has recognised an incremental impact of Rs. 262 Mn. for the Quarter ended 31<sup>st</sup> March 2026 and Rs. 414 Mn. for the year ended 31<sup>st</sup> March 2026 as past service cost on post-employment defined benefits for its employees. Considering that this impact is driven by a regulatory change and is non-recurring in nature, it is classified under exceptional items in these financial results. The Company continues to monitor the developments relating to the implementation of the New Labour Codes and would review the estimates as further clarifications and Rules are notified.
4. The above results have been reviewed by the Audit Committee and approved by the Board of Directors at their respective meetings held on 31<sup>st</sup> July 2026.
