Notice is hereby given that the Fortieth (40th) Annual General Meeting (AGM) of the Members of Atma Industries Limited (formerly known as Jyotirgamy Enterprises Limited) will be held on Monday, 07th September, 2026, 12:00 PM IST through Video Conferencing (VC)/other Audio Video Conferencing (OAVM) to transact the businesses as set out in the Notice dated 07th August, 2026.

In compliance with the MCA and SEBI Circulars, Electronic copies of the Notice of the AGM and Integrated Annual Report of the Company for the Financial Year 2025-2026 have been sent to those Members whose e-mail addresses are registered with the Company/Depositories. The dispatch of Notice of the AGM through emails has been completed on Saturday, 08th August, 2026. Members attending the AGM through VC/OAVM shall be reckoned for the purpose of quorum under Section 103 of the Act.

The remote e-voting period commences on Friday, 04th September, 2026, at 09:00 A.M. and ends on Sunday, 06th September, 2026, at 05:00 P.M. During this period, members of the Company holding shares either in physical form or in dematerialized form, as on the cut-off date i.e., Monday, 31st August, 2026, may cast their vote by remote e-voting on the business specified in the Notice of the AGM dated 07th August, 2026. Any person, who acquires shares of the Company and becomes member of the Company after dispatch of the soft copy of Notice and Annual Report as of the cut-off date i.e. Friday, 31st July 2026 may follow the same procedure for remote e-voting as given in the Notice of AGM. The remote e-voting module shall be disabled by MUGF Intime India Private Limited for voting thereafter. Once the vote on a resolution is cast by the members, the member shall not be allowed to change it subsequently.
