Cheema Accuses Centre of Using Agencies to Target Opposition Leaders

Chandigarh : Punjab Finance Minister and senior AAP leader Harpal Singh Cheema today accused the BJP-led Centre of using central investigative agencies to intimidate Opposition leaders and undermine elected state governments. Cheema alleged that agencies such as the Enforcement Directorate, CBI and Income Tax Department were being used to threaten political opponents and local administrations, particularly when elections were approaching or Opposition governments refused to bow to pressure. He also criticised the Shiromani Akali Dal, accusing it of acting as a "spokesperson" for the BJP

and central agencies over the ED's communication to the Punjab DGP. Cheema said the SAD had "completely abandoned its principles" and was attempting to use the ED communication to defame the AAP government. He further alleged that the previous SAD-BJP governments in Punjab had damaged the state's social fabric, economy and youth, citing drug abuse, sacrilege incidents and corruption. Cheema accused the BJP-led Centre of "systematically undermining the Constitution" and said the AAP would continue to defend democratic institutions and the rights of elected state governments.

Injured Boy Carried on Bed Across Swollen Rivulet as Villagers Struggle Without Bridge

Kangra : Residents of Ludhiana village in Jawali subdivision of Kangra district faced a dangerous ordeal today when they had to carry an injured boy on a bed across a swollen Anad rivulet to reach the nearest road. The boy had suffered a leg fracture in a road accident. With no proper road connectivity to upper Ludhiana, villagers carried him on their shoulders and waded through the flooded causeway amid a strong water current. He was later taken to a private hospital in Pathankot. A video of the incident, recorded by a local resident and shared on social media, went viral, receiving more than nine lakh views within 25 hours. The footage has once again highlighted the decades-old connectivity problem faced by villagers.

Residents said the Anad rivulet becomes particularly dangerous during the monsoon, when rising water levels, silt and debris make the causeway difficult and risky to cross. They said repeated demands for a permanent bridge have remained unanswered. Local residents and panchayat representatives have urged the authorities to construct a bridge at the earliest. Social activist Rohit Chaudhary said more than 700 people, including 442 registered voters, live in the affected ward and are forced to risk their lives whenever the rivulet swells. Villagers said the lack of a bridge becomes especially critical during medical emergencies, when patients and accident victims have to be manually carried across the flooded waterway.

12.80 Lakh Punjab Voters to Face Verification After SIR Draft List

Chandigarh : The number of voters in Punjab's draft electoral roll is set to fall from 2.14 crore in June 2026, before the Special Intensive Revision (SIR), to around 1.93 crore. Around 12.80 lakh voters whose forms could not be collected during the first phase of the SIR will now have to appear before officials assigned to the revision process. Notices are being issued to the concerned voters,



specifying the date and time for verification. The Election Commission of India has given these voters one month to submit their claims along with relevant documents.

Ludhiana recorded the highest number of uncollectable forms at 4.16 lakh, followed by Amritsar with 2.42 lakh, Jalandhar with 1.84 lakh, Mohali with 1.53 lakh and Patiala with 1.38 lakh.

The verification process is aimed at ensuring that eligible voters are included in the final electoral roll while removing discrepancies from the draft list.

Centre Sidesteps Chandigarh Power Bill Rise Query in Lok Sabha

Chandigarh : The Centre today did not provide category-wise data comparing electricity bills before and after the privatisation of power distribution in Chandigarh, despite a specific query from Chandigarh MP Manish Tewari in the Lok Sabha.

Tewari had sought average monthly bills for residential, commercial and industrial consumers before and after privatisation, along with details of smart-meter installations, billing complaints and any assessment of the impact of the handover. In its reply, the Ministry of Power said electricity tariffs in Chandigarh are determined by the Joint Electricity Regulatory Commission (JERC). However, it did not provide the requested comparison of average bills or clarify whether consumer bills had increased after privatisation.



The ministry said 3,300 additional smart meters had been installed after privatisation, taking the total number to 27,100. It also reported that 9,257 billing-related complaints were registered during 2025-26 and resolved through the grievance-redressal mechanism. Reacting to the reply, Tewari termed it "evasive" and said the government had failed

to provide key information sought in his question. He also questioned the limited number of new smart-meter installations and said the response was disappointing. The Centre's reply also did not provide details of any formal post-privatisation assessment comparing billing accuracy, tariffs and operational efficiency in Chandigarh.
