Parl Deadlock...

The Opposition MPs, including Congress general secretary Priyanka Gandhi Vadra and Samajwadi Party chief Akhilesh Yadav, held placards demanding accountability for alleged police action against students in Delhi last month. Their banner carried the slogan "Order kisnay diya?" (Who gave the order?).

Congress president Mallikarjun Kharge rejected the government's charge that the Opposition was avoiding debate and said the party's demands had remained unchanged.

"We are not changing our goalpost. Our position has remained consistent from the very beginning," Kharge said.

Cabinet's Rs 47,990 cr...

Rs 28,083.47 crore have been earmarked to National Health Mission. A sum of Rs 795.59 crore was approved for continuation of Block Grant Scheme till five years in respect to Jawahar Lal Nehru Agriculture University. A sum of Rs 2.50 crore was sanctioned for maintenance of properties of Mining Department.

Marking e-attendance...

Network-less schools to be identified for guest teachers rejoining- The DPI has directed all DEOs to identify schools where telecom network connectivity is unavailable and provide details of guest teachers affected by the issue. The DPI said guest teachers had been engaged against vacant posts during the 2025-26 academic session. However, in schools where telecom network connectivity was unavailable, their honorarium could not be processed and they were also unable to complete the rejoining process for the current academic session.

State of border will...

India and China rolled out a series of measures in the last over one year to rebuild their relationship after it came under severe strain following the deadly Galwan Valley clashes in 2020 and the subsequent military face-off that lasted for over four years.

In October 2024, the two sides firmed up a disengagement pact for Depsang and Demchok, the last two friction points in eastern Ladakh.

Days after the agreement was finalised, Prime Minister Narendra Modi and Chinese President Xi Jinping held talks in Kazan and took a number of decisions to improve the ties.

In August last year, Modi travelled to the Chinese city of Tianjin to attend the annual SCO summit. Modi and Xi held extensive talks on the sidelines of the SCO (Shanghai Cooperation Organisation) Summit.

In the meeting, Modi said India is committed to taking forward its ties with China based on mutual trust, respect and sensitivity.

SC asks 19 states...

"The continued non-notification of cancer, despite its alarming and escalating burden in India, amounts to a grave abdication of the State's constitutional duty under Articles 14 and 21 of the Constitution, as it denies uniform treatment to similarly-situated citizens and undermines their fundamental right to health and a life with dignity," it has said.

Besides the Centre and all the states, Srivastava, the former head of the Department of Surgical Disciplines at the All India Institute of

Medical Sciences (AIIMS), New Delhi, has made the National Institute of Cancer Prevention and Research a party to the PIL.

The plea says the absence of mandatory reporting has led to fragmented data, poor surveillance and a "policy paralysis" in addressing India's growing cancer epidemic.

The petition has urged the bench to direct authorities to declare cancer a notifiable disease nationwide and establish a unified, real-time digital cancer registry akin to the CoWIN platform launched during the COVID-19 pandemic.

PWD chief engineer...

A trap team was formed led by Praveen Singh Parihar and other ranks.

On Tuesday, at the residence of the CE, as soon as the amount was handed to Bharti, the trap team caught them red-handed.

SC notice to govt on...

A satirical online movement called the "Cockroach Janta Party" subsequently emerged and gained significant traction on social media. The material provided states that it attracted hundreds of thousands of followers on X and more than 22 million followers on Instagram.

The petition alleges that the controversy was turned into a vehicle for branding, publicity, online engagement and commercial activity. It also points to multiple trademark applications for the expression "Cockroach Janta Party".

"Issue an appropriate writ, order, or direction directing competent authorities to examine and take action in accordance with law against persons/entities allegedly involved in commercial exploitation, trade mark appropriation, monetised circulation, or unauthorised commercial use of oral courtroom observations and symbolic expressions arising from proceedings before the Supreme Court of India, including activities associated with 'Cockroach Janta Party'," the plea said.

The petitioner clarified that the plea does not seek to curb criticism of the judiciary, democratic dissent, satire or free speech protected under Article 19(1)(a) of the Constitution. It instead alleges organised commercial exploitation, trademark commercialisation and monetised circulation of courtroom proceedings.

Inside Trump's...

Before leaving Ankara, Trump said he would use the older, baby blue Air Force One "for old time's sake" to RAF Mildenhall in Britain, while the new aircraft would stop there for US service members to tour.

Journalists aboard the older aircraft were told to keep their window shades closed, while some White House staff also believed Trump was on board.

Asked later why the shades had to remain shut, Trump said they were "probably on a dangerous flight". He added: "But if I go, you go. Right?"

Trump instead travelled aboard a C-32A, which reached Britain at about 10.20pm local time. The older Air Force One carrying the media arrived minutes later.

The New York Times reported: "Mr Trump was brought by vehicle from the third plane that he had arrived on to the older Air Force One, boarded it through a different entrance and strode down the step from the upper left-side door as he would typically do, according to (a) US official."

Trump's travelling press pool reported that he descended from the older Air Force One at 10.56pm, gave the press a peace sign and greeted service members before walking to the Qatar-donated aircraft.

MAYHEM| IMD issues orange alert for five districts

Monsoon fury kills 157 in Himachal, shuts 260 roads

Himachal Pradesh's monsoon misery is deepening by the day, with as many as 259 roads blocked across the state and landslides and rain-related incidents claiming 157 lives. Nearly 900 properties and public works have been damaged amid the relentless rainfall, with losses estimated around Rs 886 crore, according to the latest State Emergency Operations Centre (SEOC) report.

As per the report, which covers the period from June 30 to August 9, around 68 people died due to landslides and flash floods, while 89 others were killed in road accidents. Around 257 people are missing. The troubles for Himachal, however, seem to be far from over as the IMD has issued an orange alert for heavy rain in five districts.

Power supply hit

HITPower supplies have also taken a hit across the state, with Kullu and Mandi districts being the worst hit. Around 161 distribution transformers (DTRs)



have been rendered non-functional for over a week. Mandi accounts for the highest number at 77, followed by Shimla with 43 and Kullu with 40.

The incessant rain, an annual affair at this time in Himachal, has led to a sudden rise in water levels in rivers and streams across Kullu. Dramatic visuals show debris crashing down the mountains and flash floods sweeping away cars and makeshift bridges. Its neighbouring Himalayan state, Uttarakhand, has also been battered by the monsoon mayhem.

In one of the most horrifying

visuals emerging from the state, a metal bridge was seen being ripped apart and swept away by a gush of water in the picturesque Niti Valley in Chamoli district.

Kullu, Mandi worst hit

Landslides and landslips have left around 259 roads inoperable, including the crucial Mandi-Kullu highway. Mandi is the worst affected, with 120 roads shut, followed by Chamba (42), Kullu (40) and Shimla (30).

Pathak slams RaGa over student protests

Uttar Pradesh Deputy Chief Minister Brijesh Pathak on Tuesday accused Congress leader Rahul Gandhi of adopting a "double standard" on student protests, alleging that he speaks out when students protest against BJP governments but remains silent when similar demonstrations are met with police action in Jharkhand.

Addressing a press conference, Pathak said Rahul Gandhi had repeatedly raised student issues at Jantar Mantar in Delhi and criticised the Centre over unemployment, recruitment and examination-related concerns. However, he questioned the Congress leader's silence over the alleged police action against protesting students in Ranchi. Pathak alleged that students protesting over jobs, recruitment and paper leaks in the Jharkhand capital were stopped with barricades and barbed wire and that police used water cannons and resorted to lathi charges.

Rajasthan turns to tribal tourism

Rajasthan, known globally for its desert landscapes and royal heritage, is now looking to put its tribal heartland on the international tourism map, with the state government proposing tourism projects worth around Rs306 crore in the southern tribal belt.

The proposed projects seek to develop a Tribal Tourist Circuit and a Maharana Pratap Tourist Circuit, besides promoting the region's religious, historical and cultural heritage. The initiative covers tribal-dominated districts, including Udaipur, Pratapgarh, Dungarpur, Banswara and parts of Sirohi, which are known for their lush landscapes, indigenous traditions and historical sites.

Under the Tribal Tourist Circuit, Rs49.4 crore has been proposed for the development of Beneshwar Dham in Dungarpur, popularly known as the "Kumbh of the tribals". Another Rs13.41 crore has been earmarked for Mangarh Dham in Banswara, a site closely associated with the tribal freedom struggle.

The circuit will also cover important religious and cultural destinations such as Matrikundiya in Chittorgarh, known as the Prayag of Mewar; Sitamata Sanctuary in Pratapgarh; Gautameshwar Mahadev Temple; Tripura Sundari Temple in Banswara; and Rishabhdev Temple in Udaipur.

Officials said the focus would be on increasing the duration of tourists' stays in tribal areas while creating employment and self-employment opportunities for local communities and self-help groups.

"Special efforts will increase tourist stays in tribal areas while also providing employment opportunities for local people and self-help groups with ample opportunities for self-employment," officials said.

The government has separately proposed spending more than Rs206 crore on the Maharana Pratap Tourist Circuit, aimed at integrating sites associated with Maharana Pratap and the history of Mewar. The circuit will include Chavand, Haldighati, Gogunda, Kumbhalgarh, Diwar and Udaipur.

Temple Trust begins CEO selection, 18 face interviews

The selection process for the first full-time Chief Executive Officer of the Shri Ram Janmabhoomi Teerth Kshetra Trust entered its final stage on Tuesday as interviews of shortlisted candidates began at the Ram temple complex in Ayodhya.

A three-member selection committee started one-on-one interviews of 18 candidates on Tuesday morning. The process is expected to continue on Wednesday. The panel will subsequently recommend three names to the Trust for final consideration, with the appointment likely to be announced in the Trust meeting scheduled for September 2.

The Trust had opened applications for the CEO post in early July, with the last date for submission set as July 18. More than 5,200 applications were received from across the country. After nearly 20 days of detailed scrutiny, the selection committee shortlisted 18 candidates for the interview round.

The shortlist includes retired bureaucrats, former senior corporate executives, retired defence officials, and a few candidates with experience in managing large temples and religious trusts,

including from South India.

The interviews are being conducted by a high-level three-member panel comprising Justice Pramod Kohli, a retired Supreme Court judge, Lieutenant General Vishnukant Chaturvedi, who is retired from the Army, and Suresh Haware, a retired nuclear scientist and former chairperson of the Shri Saibaba Sansthan Trust in Shirdi.

The panel is holding closed-door interviews at the pilgrim facilitation centre within the Ram temple complex. All 18 candidates have reached Ayodhya for the interviews. The Trust had laid down clear eligibility criteria for the CEO position. Candidates must be Indian citizens, practising Hindus, and graduates between 50 and 70 years of age. They should have a minimum of 20 years of experience in administration, finance or management. Prior experience in managing temples or religious institutions has been given preference.

Fluency in both Hindi and English is mandatory. The selected candidate will be required to reside in Ayodhya during the tenure and is expected to be a strict vegetarian and teetotaler, adhering to Hindu traditions.

The CEO will be appointed initially for a three-year term.

Jharkhand bandh over police 'atrocities', students seek CBI probe

The Jharkhand BJP has called for a statewide bandh on Tuesday to protest the police action against students during a march by JPSC and JSSC aspirants in Ranchi, with party state president Aditya Sahu alleging that hundreds of protesters were injured in the lathi-charge and use of tear gas and water cannons. The bandh has been announced from 8 am to midnight.

Sahu launched a sharp attack on the Hemant Soren-led government, saying the bandh was being observed in protest against what he described as "injustice and atrocities" against students.

He alleged that students had faced issues including the alleged selling of jobs and advance leaking of examination papers, while accusing the police of using excessive force against protesters.

Jharkhand Assembly adjourned sine die

Jharkhand Assembly was adjourned sine die on Tuesday, a day ahead of schedule, amid a stormy confrontation between the ruling JMM-led coalition and BJP legislators

Mahto critical after march, hospitalised

Patna: Jharkhand student protest leader Devendra Nath Mahto was hospitalised on Monday after his health deteriorated while taking part in the student-led march in Ranchi. Doctors described his condition as critical after a "drastic" drop in his blood sugar level.

Despite his condition, Mahto joined the protesters during their march towards the Assembly earlier on Monday. He arrived at the protest site in an ambulance.

He alleged that police pushed and harassed him and forcibly put him in an ambulance despite his nine-day fast.

The assembly's monsoon session was scheduled to continue till Wednesday, but Speaker Rabindra Nath Mahato brought the session to an early close after repeated disruptions, saying he was forced to take the decision with a "heavy heart and pain".
