I, Prashant S. Mehta, Practising Company Secretary, appointed as Scrutinizer by the Board of the Directors of Kaira Can Company Limited at its meeting held on June 25, 2026 for the purpose of scrutinizing the e-Voting Process, in a fair and transparent manner at the 63rd Annual General Meeting held on August 7, 2026 hereby submit my report as under:

1. The Ministry of Corporate Affairs ("MCA") has vide its circular no. 03/2025 dated September 22, 2025 read with Circular No. 09/2024 dated September 19, 2024, Circular No. 09/2023 dated September 25, 2023, Circular no. 10/2022 dated December 28, 2022, Circular No. 14/2020 dated April 08, 2020, Circular No.17/2020 dated April 13, 2020 and Circular No. 20/2020 dated May 05, 2020, (collectively referred to as "MCA Circulars") has permitted the holding of the Annual General Meeting ("AGM") through Video Conferencing ("VC") or Other Audio Visual Means ("OAVM"), without the physical presence of the Members at a common venue. In compliance with the provisions of the Companies Act, 2013 ("Act"), SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations") and aforesaid MCA Circulars, the AGM of the Company was held through VC / OAVM.
2. In compliance with the aforesaid MCA Circulars and SEBI Circulars, the Annual Report along with the Notice of the 63rd Annual General Meeting for the financial year 2025-26 had been sent only through electronic mode to those Members whose email addresses are registered with the Company/ Depositories/Registrar and Share

Transfer Agents (RTA). Notice of the Annual General Meeting and Annual Report 2025-26 were also available on the Company's website, websites of Stock Exchange i.e. BSE Limited and on the website of Central Depository Services (India) Limited (CDSL) and the dispatch for the same had been completed on July 14, 2026. In compliance with the SEBI Listing Regulations, the Company has sent a letter on July 14, 2026, to those Members whose e-mail addresses were not registered with the Company / Depository. The letter provided the web link to the Company's website, from which the Annual Report for the financial year 2025-26 can be accessed.

3. The Members of the Company were given option to vote electronically on Remote E-Voting system, provided by Central Depository Services (India) Limited ("CDSL"). The Remote E-voting period commenced on Monday, August 3, 2026 (9:00 a.m. IST) and ended on Thursday, August 6, 2026 (5:00 p.m. IST).
4. In compliance with the MCA Circulars, voting by means of a poll at the AGM by filling physical ballot papers was dispensed with as no physical AGM was convened. The members who have not voted during the remote e-voting but were present in the AGM through VC / OAVM facility, were allowed to vote through e-voting system during the AGM.
5. The management of the Company is responsible to ensure compliance with the requirements of (i) the Act, the Rules made thereunder and the MCA Circulars; (ii) the SEBI (Listing Obligations & Disclosure Requirements) Regulations 2015, ("LODR") as amended and SEBI Circulars in this regard. The management of the Company is also responsible for ensuring a secured framework and robustness of the electronic voting systems.
6. My responsibility as Scrutiniser for e-voting process (i.e. remote e-voting and e-voting at the Meeting) is restricted to making a Scrutiniser's Report of the votes cast "in favour" or "against" the resolutions contained in the Notice, based on the reports generated from the e-voting system provided by Central Depository Services (India) Limited ("CDSL"), the Agency authorized in accordance with the applicable Rules under the Act and engaged by the Company to provide the facility of remote e-voting and e-voting at the Meeting and attendant papers / documents furnished to me electronically by the Company and / or CDSL for my verification.
7. The equity shareholders of the Company as on the "cut-off" date, as specified in the Notice, i.e., Friday, July 31, 2026 were entitled to vote on the resolutions as set out in the Notice calling the Meeting and their voting rights were in proportion to their shareholding in the paid-up equity share capital of the Company as on the cut-off date.
8. After the conclusion of the AGM on August 7, 2026 I have downloaded, scrutinized and counted the votes cast through remote e-Voting and e-voting at the AGM, for the purpose of this report.
9. I have unblocked the electronic votes cast through remote e-voting and e-voting at the AGM from the e-voting website of CDSL.
